1. India's Smriti Mandhana regained the No. 1 position in ODI ranking

- **Current Ranking**: Mandhana has 727 rating points, surpassing England's Natalie Sciver-Brunt (719 points) and South Africa's Laura Wolvaardt (719 points), who are ranked second and third, respectively.
- **Recent Performance**: Mandhana's rise to the top spot is attributed to her impressive performance in the

recent tri-series against Sri Lanka and South Africa in Colombo, where she scored 264 runs across five matches, including a century in the final.

- **Career Statistics**: Mandhana has played 102 ODI matches for India, scoring 4473 runs at an average of 46.59 and a strike rate of 87.79.
- Other Indian Batters: Jemimah Rodrigues and captain Harmanpreet Kaur are ranked 15th and 16th, respectively, in the latest ICC ODI batting rankings.

2. Jio Financial Becomes Sole Owner of Jio Payments Bank

- Acquisition Details: Jio Financial Services Ltd (JFSL) has acquired State Bank of India's (SBI) 17.8% stake in Jio Payments Bank for ₹104.54 crore, valuing the bank at approximately ₹586 crore.
- Ownership Structure: JFSL now owns 100% of







Jio Payments Bank, having increased its stake from 82.17%. The transaction was approved by the Reserve Bank of India (RBI) on June 4, 2025.

• **Strategic Implications**: Full ownership gives JFSL greater autonomy in integrating digital banking with other financial services. This move aligns with Jio's digital-first, data-driven approach and could drive a unified digital finance ecosystem.

3. Maharashtra Makes Hindi 'General' Third Language in Schools

• The revised Government Resolution (GR) states that Hindi will "generally" be taught as the third language for students in Classes 1 to 5 in Marathi and English medium schools, aligning with the National Education Policy (NEP) 2020 and the State Curriculum Framework 2024.



- While Hindi is the default, students have the option to choose another Indian language as their third language.
- This option is conditional at least 20 students in a class must opt for that specific alternative language. If this threshold is met, a teacher will be provided, or the language will be taught online.
- Irrespective of the medium of instruction (Marathi, English, or any other), Marathi remains a compulsory language across all schools in Maharashtra.

4. India France Joint Exercise 'Shakti 2025' Begins in France





• Exercise Details: The 8th edition of Exercise Shakti began on June 18, 2025, in La Cavalerie, France, and will conclude on July 1, 2025. This biennial exercise is alternately hosted by India and France, with the last edition taking place in



Meghalaya, India, in May 2024.


- **Objective**: The primary aim of Exercise Shakti 2025 is to enhance the joint military capability of both nations to undertake multi-domain operations in subconventional scenarios, such as counter-terrorism and counter-insurgency operations.
- **Participating Forces:** The Indian contingent consists of 90 personnel, primarily from the Jammu and Kashmir Rifles, while the French contingent also comprises 90 personnel from the 13th Foreign Legion Half-Brigade (13th DBLE).
- **Key Focus Areas**: The exercise will focus on developing interoperability, tactical coordination, and mutual understanding between the participating contingents.
