IDFC FIRST Bank Launched UPI-enabled FIRST EARN Credit Card



#### 1. IDFC FIRST Bank Launched UPI-enabled FIRST EARN Credit Card

This innovative card allows users to link their credit accounts to UPI for hassle-free transactions, combining the flexibility of UPI with the benefits of a credit card. Customers can enjoy enhanced spending limits, reward points, and cashback offers while making payments directly from their UPI apps. The card is designed to cater to the evolving needs of tech-savvy



customers, ensuring secure and convenient usage. With this launch, IDFC FIRST Bank aims to revolutionize the credit card market by integrating advanced digital payment solutions.

- The FIRST EARN Credit Card is a digital credit card that can be used to make payments at over 60 million merchants via UPI, and it also offers cashback on every spend, with 1% cashback on spends via the IDFC FIRST Bank mobile app and 0.5% cashback on UPI spends via other apps and online spends.
- The credit card has a joining fee of 499 + GST and an annual fee of 499 + GST from the second year onwards, with an interest rate starting from 0.75% per month (9% p.a.).
- To apply for the FIRST EARN Credit Card, users need to register and verify their details, create a fixed deposit with IDFC FIRST Bank, and complete their KYC process.
