## Sentence Rearrangement

In all Bank Examinations section of general English contains five or ten questions relating to arranging the sentences. These sentences are part of paragraph. In exam these sentences are given in improper order. The candidates are required to place these sentences in proper order or sequence to form a meaningful paragraph. These questions are asked to check compositional and organizational ability of the candidate.

## How to Attempt these Questions

1) In these type of questions five to seven sentences are given. The candidate should read all the parts and try to find out logical sequence in it.
2) The candidate should try first to find out "first and last" sentence. The first sentence will be introductory and the last conclusion or closing to the paragraph.
3) The candidate should try to find whether any chronological order follows. Then try to find the linkage how the event goes.
4) Tracing the pronoun and then finding the answer of that pronoun is also a useful technique.
