President Approves Chief Election Commissioner Bill and GST Amendment

- President Droupadi Murmu gave her assent to the Chief Election Commissioner and other Election Commissioners (Appointment, Conditions of Service and Term of Office) Bill, 2023. It was passed by the Parliament in the recently concluded Winter Session.
- The new legislation provides for the appointment, salary, and removal of the Chief Election Commissioner (CEC) and Election Commissioners (ECs). According to the provisions, the CEC and ECs will be appointed by the President upon the recommendation of a Selection Committee.

Reuse of Inert Waste under Swachh Bharat Mission 2.0

- The government has intended to link road construction with the Swachh Bharat Mission 2.0. The Ministry of Road Transport and Highways has developed a policy regarding the use of inert waste. The Minister for Road Transport and Highways, Nitin Gadkari, stated that his government has developed a draft policy to encourage the use of alternative fuels in construction equipment.
- The flagship Swachh Bharat Mission (SBM) 2.0, with its heavy focus on solid waste management, is being seen as a potential game-changer for India. The key mission agenda talks about making India "garbage-free", with components like remediation of legacy waste, and increasing capacity for treatment, processing, recovery, and recycling of municipal solid.

- With the world's largest grassroot oil refinery in Jamnagar and OPaL petrochemical complex at Dahej in Bharuch district, Gujarat is now recognised as the 'petro capital' of India, officials said. Reliance Industries Ltd's (RIL) Jamnagar refinery is the largest and most complex single-site refinery in the world with 1.4 million barrels per day (MMBPD) crude processing capacity.
- The Gujarat government, major players of this sector have scaled new heights in the global market. These companies started as small scale units but eventually grew into major players. As a result of proactive government policies, the state contributes to around 75 per cent of the country's total dye and intermediates manufacturing.

- Indian power sector is ready to meet the growing demand of Power. The demand of power is increased by 70% in the last 9 years. The Minister was addressing the audience after inaugurating the Vishram Sadan by Power Grid Corporation of India Ltd at National Institute of Medical Health and Neurosciences NIMHANS campus in Bengaluru today. He asserted that no other country had experienced such a huge demand.

Rajasthan's First Snake Park will Open in Kota

- The first snake park of the state will be opened in Kota. Its building is ready. The Central Zoo Authority (CZA) has recently approved it. Its exercise was going on for the last 19 years. A building of 9290 sq. ft. on the ground floor and 6703 sq. ft. on the first floor of Snake Park has been constructed at a cost of 7.42 crores near Herbal Park on Bundi Road.
- A special zone of glass has been made to keep other species of snakes including the rare Anaconda species. Snakes will get an atmosphere from its special tiles.it is expected that in the new year 2024, Kota will get the gift of the state's first snake park. This snake park is being constructed in the Herbal Park on Bandi Road, Kota.

The primary focus of the conference will be 'Ease of Living,' with an emphasis on formulating and implementing a unified development agenda and action plan in collaboration with the states.
- Addressing the need for easy access to welfare schemes and enhancing service quality, the
 conference will delve into five sub-themes: land and property, electricity, drinking water,
 health, and schooling. Special sessions will also explore topics such as cyber security
 challenges, perspectives on AI, stories from the ground through the aspirational block and
 district program, the role of states in streamlining schemes, and opportunities and challenges
 associated with AI in governance.

PM inaugurates Maharishi Valmiki International Airport at Ayodhya Dham

 cater to 60 lakh commuters annually.

PM inaugurates, dedicates to nation and lays the foundation stone of multiple development projects worth more than Rs 15,700 crore

- The Prime Minister, Shri Narendra Modi inaugurated, dedicated to the nation and laid the foundation stone of multiple development projects worth more than Rs 15,700 crore at Ayodhya Dham. After that, he also inaugurated the newly built Ayodhya Airport. The airport has been named Maharishi Valmiki International Airport.
- These include projects worth about Rs 11,100 crore for the development of Ayodhya and its surrounding areas and projects worth about Rs 4600 crore related to other projects across Uttar Pradesh. Earlier PM Modi inaugurated the redeveloped Ayodhya Railway Station and flagged off new Amrit Bharat trains and Vande Bharat trains.

Gujarat Sets Guinness Record In Mass Surya Namaskar



- Gujarat, known for its rich cultural heritage and commitment to health and wellness, achieved a remarkable feat on New Year's morning by making an indelible mark in the Guinness Book of World Records. The state hosted the largest simultaneous Surya Namaskar performance, involving over 4,000 participants from 108 locations across 51 categories.
- The chosen number of 108 holds special significance in Indian culture, and the venues for the mega event included the iconic Modhera Sun Temple. In Vedic culture, esteemed mathematicians regarded 108 as a symbol of complete existence, linking it to the Sun, Moon, and Earth.

Modi govt raises Sukanya Samridhi Yojana interest rate ahead of Lok Sabha election 2024

- The Narendra Modi government has hiked the interest rates for 'Sukanya Samriddhi Yojana' by 20 basis points. As per a finance ministry circular, the deposit under this scheme will now have an interest rate of 8.2 per cent instead of earlier 8 per cent, PTI reported.
- The Government recently raised the interest rates on the Sukanya Samriddhi Yojana (SSY) scheme by 20 basis points to 8.2 per cent from the existing 8 percent.SSY is a savings scheme launched in 2015 under the Government of India's "Beti Bachao Beti Padhao" campaign, which aimed to promote the education of girl children.

PM Modi to inaugurate 'India's longest sea bridge' in Mumbai

- The ambitious infrastructure project, the Mumbai Trans Harbour Link (MTHL) will be inaugurated by Prime Minister Narendra Modi on 12 January, Maharashtra CM Eknath Shinde. The MTHL project is 22 km long, touted to be India's longest and the world's 12 longest sea bridge.
- The project consists of an approximately 22 km long 6-tier (3+3-lane, 2 emergency lane) bridge connecting Shivdi in Mumbai city and Nhava on the mainland. It has been in the making since 2018. Originally expected to be completed in 4.5 years, the infrastructure project was delayed by eight months due to Covid-19 pandemic.

Telangana Chief Minister Revanth Reddy Launches "Abhaya Hastam" for Congress' Six Guarantees Implementation in 100 Days

• Telangana chief minister A Revanth Reddy kickstarted "Abhaya Hastam", a programme to implement the six guarantees as promised by the Congress before the elections, and the government was committed to implementing all the promises within 100 days.



• Under this, a special campaign 'Praja Palana' (People's governance) was launched across the state on 28 December, 2023. The program, aimed at receiving applications from eligible beneficiaries of various schemes promised under Abhay Hastam, will end on January 6, 2024.

GST collections rise 10% to Rs 1.64 lakh crore in December

- The gross Goods and Services Tax, GST revenue collection in the month of December, 2023 stood at one lakh 64 thousand and 882 crore rupees. The revenue for December is 10.3 percent higher than the GST revenues in the same month last year.
- The Finance Ministry in a statement said that out of the total GST revenue collected for the month, Central Goods and Services Tax, CGST collection is 30 thousand 443 crore rupees, State Goods and Services Tax, SGST is 37 thousand 935 crore rupees, Integrated Goods and Services Tax, IGST is around 84 thousand 255 crore rupees and cess is 12 thousand 249 crore rupees.

Govt extends tenure of PLI scheme for Auto industry by a year with partial amendments

- The Ministry of Heavy Industries issued a Gazette notification to extend the tenure of Production Linked Incentive (PLI) Scheme for Automobile and Auto Components by one year with partial amendments to provide clarity and flexibility to the scheme.
- However, it will still be eligible for benefits in the following year if it meets the threshold calculated based on a 10% year-on-year increase over the earlier year's threshold. The amendment also includes changes in the table showing the incentive outlay, taking the total indicative incentive amount to Rs 25,938 crore.

It fosters respect for India's rich cultural heritage and diverse traditions, embodying the spirit of "Vasudhaiva Kutumbakam" (the world is one family).

Jharkhand govt reduces qualifying age for old-age pension to 50



- In a significant move to enhance social security and address the challenges faced by marginalized communities, Chief Minister Hemant Soren of Jharkhand announced a reduction in the qualifying age for old-age pensions. The decision primarily targets tribals and Dalits, lowering the age threshold from 60 to 50 years.
- Chief Minister Hemant Soren highlighted the historical context, emphasizing that, in the two decades following Jharkhand's formation in 2000, only 16 lakh people received pension benefits. However, under his government's tenure, pensions have been extended to an impressive 36 lakh individuals, predominantly those aged above 60 years.

Assam government initiates 'Gunotsav 2024 to assess performance of 40 lakh students in government school

- Assam Government launches 'Gunotsav 2024' a comprehensive state-wide assessment aimed at evaluating the performance of approximately 40 lakh students of 43,498 government schools spread across 35 districts. The exercise, which began yesterday, will conclude on February 8 in three phases. The first phase covering 12 districts from January 3 to 6, the second phase involving 13 districts from January 10 to 12, and the final phase comprising the remaining 10 districts scheduled from February 6 to 8.
- Gunotsav, an initiative of the Government of Assam, is covering all government Elementary and Secondary schools in the state. To facilitate the assessment process, a total of 18,098 external evaluators deployed throughout the State. This diverse group of evaluators will include the chief minister, MLAs, the chief secretary, and college teachers, Government Officers among others to visit schools as external evaluators.

UP CM Launches Mobile App Of State Information Commission

- Uttar Pradesh Chief Minister Yogi Adityanath launched a software and a mobile application to facilitate e-filing and online hearing of complaints and second appeals in the State Information Commission. After launching the complaint and appeal tracking system at the RTI Bhawan.
- Technology can become a powerful medium to bring changes in a person's life. With the launch of this software and mobile application, no person will have to physically come to the State Information Commission office for their complaints.

Tamil Nadu Kicks Off First Jallikattu Event of the year

• Jallikattu, the traditional bull-taming sport, kicked off the year in Tamil Nadu with an event in Thachankurichi village featuring 500 bulls and heavy security. A five-judge Constitution



- bench of Justices KM Joseph, Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy and CT Ravikumar was hearing a batch of petitions challenging Tamil Nadu and Maharashtra governments' laws allowing the bull-taming sport 'Jallikattu' and bullock cart races.
- The event was declared open by Minister for Law S. Raghupathy and Minister for Environment and Climate Change Siva V. Meyyanathan .Mr. Raghupathy administered the oath to the tamers. District Collector I.S. Mercy Ramya and other officials were present.

Indian economy to grow at 7.3% in current financial year

- The National Statistical Office (NSO) under the Ministry of Statistics and Programme Implementation has said that the Indian economy will grow by a robust 7.3 per cent in the Financial Year 2023-24 over and above the provisional growth rate of 7.2 per cent during the last financial year.
- NSO in its report based on First Advance Estimates (FAE) of National Income for the financial year 2023-24, said that the construction sector has been estimated to have double-digit growth of 10.7 per cent. It highlighted that all the economic sectors have fared well by witnessing more than six per cent, except for the Agriculture and Allied sectors, for which the estimated growth is 1.8 per cent.

Shri Nitin Gadkari inaugurates and lays the foundation stone of 12 National Highway projects with a total length of 105 km worth over Rs 1464 Crore in Kerala

- In Kerala, Union Minister of Road Transport and Highways Nitin Gadkari will inaugurate and lay the foundation stone of 12 National Highway projects at a function to be held at Kasaragod. The projects, worth over 1464 crore rupees have a total length of 105 km.
- Union Ministers Dr V K Singh, V Muraleedharan, and State Public Works Minister Muhammed Riyas are among those scheduled to attend. Furthermore, a focus on eliminating black spots on National Highways is anticipated to contribute to a significant decrease in road accidents.

Paytm Enters Partnership with Ayodhya Nagar Nigam to Facilitate Mobile Payments Across the City

Finance Ministry Greenlights an Additional Rs 1,500 Crore for FAME-II Scheme

- In a strategic move to further propel the adoption of electric vehicles (EVs) in India, the Union Finance Ministry has greenlit an additional allocation of Rs. 1,500 crore for the second phase of the Faster Adoption and Manufacture of Electric Vehicles (FAME-II) program.
- he target for supporting the number of vehicles has been raised from 1.56 million to 1.74 million. The target for electric two-wheelers (e2Ws) increased by 50% to 1.55 million. The target for electric three-wheelers (e3Ws) was reduced by 68% to 155,536.



Gujarat to host tenth edition of Vibrant Gujarat Global Summit commencing in Gandhinagar

- Gujarat is all set to host the tenth edition of the Vibrant Gujarat Global Summit commencing on the coming 10th of January at Mahatma Mandir in Gandhinagar. The Tenth edition will celebrate "20 Years of Vibrant Gujarat as the Summit of Success". The theme of the summit this time is 'Gateway to the Future'.
- Akashvani's correspondent reports that the tenth edition of the summit is unique in many
 ways. The tenth edition Vibrant Gujarat Global Summit is being held after a gap of four
 years as the summit was canceled in 2021 due to the Covid-19 pandemic. The anamorphic
 projection facility will be used for the first time at the Vibrant Gujarat Global Summit this
 year.

Kyrgyzstan Declared 'Snow Leopard' As National Symbol



- Kyrgyzstan, a country nestled in the heart of Central Asia, has officially declared the snow leopard as its national symbol, signifying a profound commitment to conservation and ecological balance. President Sadyr Zhaparov, through a signed decree, emphasized the snow leopard's role not only as a symbol of natural wealth and cultural prosperity but also as a vital indicator of the stability and health of the mountain ecosystems that cover a substantial portion of the global territory.
- President Zhaparov's decree highlights the crucial role of snow leopards in maintaining ecological equilibrium. The loss of these majestic creatures in the wild poses a significant risk to the fragile balance of the mountain ecosystem, with potential detrimental impacts on various animal species and even on human populations.

PM Modi to inaugurate India's longest sea Bridge Atal Setu in Mumbai on January 12 during Maharashtra visit

- Mumbai and Navi Mumbai have only two road connectivity options. The MTHL is also
 expected to strengthen connectivity between Mumbai Port Trust (MbPT) and Jawaharlal
 Nehru Port Trust (JNPT), playing a pivotal role in stimulating urban and industrial
 development.
- The inauguration of this sea bridge also stands as a testament to India's growing infrastructure prowess. In December 2016, PM Modi laid the foundation stone of the bridge. Marking the historic milestone in India's infrastructure development, the name Atal Setu also honours the former Prime Minister Atal Bihari Vajpayee.

Maharashtra establishe Atpadi conservation reserve to safeguard endangered canids

- The Maharashtra government has established a crucial new wildlife habitat in Sangli district, aptly named the Atpadi Conservation Reserve. Spanning a compact 9.48 sq. km, this reserve prioritizes the protection of the endangered 'canid' family, including wild dogs, wolves, jackals, and foxes.
- Strategically located, Atpadi bridges the gap between the Maini Conservation Area and the Madhok Bird Sanctuary, fostering a safe wildlife corridor. This diverse sanctuary boasts three distinct forest types semi-evergreen, moist deciduous, and dry deciduous.

'Prasadam' India's first hygienic food street in Ujjain

• Spanning an impressive 939 square meters, "Prasadam" stands as a symbol of holistic development. Positioned near the Mahakaleshwar Temple, it is designed not just as a food



- street but as a multifaceted destination contributing to various aspects of community life. The food street comprises 17 shops, each offering a unique culinary experience.
- "Prasadam" goes beyond offering a culinary delight. It provides an array of facilities, including a dedicated kids' play area, drinking water facility, CCTV surveillance, ample parking, public conveniences, and spacious seating areas. These facilities are aimed at enhancing the overall experience for visitors and locals alike.

Supreme court orders constitution of committee in all high courts for implementation of Judicial pay commission

- Observing that judicial service cannot be equated with the service of other officers of the Government, the Supreme Court rejected the argument that the pay and allowances of judicial officers and other government officers should be equivalent.
- The Court made this observation in the judgment passed in the All India Judges Association case directing the States to implement the recommendations of the Second National Judicial Pay Commission regarding the pay and allowances for judicial officers.

Chandubi festival was celebrated along the chandubi Lake in Assam

- Preserving the waterbody, the water level of which has rapidly been lowering over the years, has been the motive for organising the festival every year. It is organised every year for five days starting from the first day of the New Year along the Chandubi lake, which is situated in the state of Assam.
- The main attractions of the Chandubi festival are the local folk culture, ethnic cuisine, local handloom and dresses, boating, etc.The major aim of the Chandubi Festival is to promote eco-tourism in this biodiversity hotspot of Assam.

Yuva Nidhi Scheme launched by Karnataka government for unemployed youth

- Chief Minister Siddaramaiah and Deputy CM D.K. Shivakumar launched the Yuva Nidhi scheme, the fifth poll guarantee of the Congress for educated unemployed youth of Karnataka, in Shivamogga. Apart from their Cabinet colleagues, thousands of people and youths from Shivamogga and neighbouring districts turned up for the launch.
- The scheme offers financial aid to graduates and diploma holders who are yet to get a job, but only for a maximum of two years. Training will be provided to the graduates and diploma holders who register themselves on the skill connect portal of the State Government.

Govt's ZED scheme for MSMEs hits 1 lakh certification milestone



- The Zero Effect, Zero Defect scheme (ZED) by the MSME Ministry has achieved a significant milestone of certifying 1 lakh (100,000) Micro, Small, and Medium Enterprises (MSMEs) for environmentally conscious manufacturing practices.
- The Zero Effect, Zero Defect scheme (ZED) was launched in October 2016 and revamped in April 2022, aims to encourage sustainable manufacturing and reduce environmental impact. The scheme was made free for women-led MSMEs in December 2023, and the government guarantees 100% financial support for certification costs.

PM Modi Releases First Instalment of PM-JANMAN Scheme for Pucca Homes

- In a significant move towards uplifting Particularly Vulnerable Tribal Groups (PVTGs), Prime Minister Narendra Modi is set to release ₹540 crore, the inaugural tranche of funding, for pucca homes under the Pradhan Mantri Awas Yojana-Gramin (PMAY-G) on January 15. This disbursement, part of the recently launched PM-JANMAN package, aims to foster the comprehensive development of PVTG habitations.
- The Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) was launched on November 15, 2023. It is a significant government initiative targeting the socio-economic welfare of Particularly Vulnerable Tribal Groups (PVTGs) in India.

Maharashtra's Pench Tiger Reserve Achieves Milestone as India's First Dark Sky Park

- The Pench Tiger Reserve (PTR) in Maharashtra has been marked as India's first Dark Sky Park and the fifth such park in Asia for protecting the night sky and preventing light pollution, making the facility ideal for astronomy enthusiasts.
- The International Union for Conservation of Nature (IUCN) emphasises on the recognition of the intrinsic value of the night sky as a natural, cultural, and historical resource. The reserve has inaugurated a night observatory with the district planning committee (DPC) fund.

Ganga Sagar Mela, India's second-largest fair after Kumbh Mela, is celebrated in West Bengal of India

The Ganga Sagar Mela stands as a testament to the vibrant cultural and spiritual tapestry of
India. Held annually in Sagardwip, West Bengal, this magnificent fair has earned the
distinction of being the second most popular mela in the country, surpassed only by the
revered Kumbh Mela.



• The festival draws a massive influx of devotees who converge to partake in rituals, seek spiritual purification, and celebrate with immense fervor. Held during the winter season, the Ganga Sagar Mela is a sacred gathering where pilgrims immerse themselves in the holy waters of the Ganga River to cleanse their souls. The Ganga, considered the holiest river in Hindu mythology, culminates its journey in Sagardwip, merging with the Bay of Bengal.

Delhi LG Kicks Off 2-Day Global 'Patang Utsav' At Baansera

- Delhi Development Authority (DDA) will organise two days International Kite Festival 'Patang Utsav' at Baansera--Delhi's first bamboo park at Sarai Kale Khan on bank of river Yamuna, on January 13-14. Speaking at the inauguration, Lieutenant Governor VK Saxena commended the Delhi Development Authority for spearheading the festival and transforming previously degraded landscapes into open green spaces.
- While entry to the place will remain ticketed, the authority has planned various arrangements to facilitate visitors. DDA will bring professional artists from Gujarat for flying and displaying huge kites and the general public can also participate in large number.

Yuva Nidhi scheme was launched by Karnataka Government for providing financial aid to unemployed graduates and diploma holders

- Karnataka Chief Minister Siddaramaiah recently unveiled the fifth and final poll guarantee of the Congress party, named the 'Yuva Nidhi' scheme. Launched at Freedom Park in Shivamogga, this initiative aims to provide unemployment assistance to graduates and diploma holders who completed their degrees during the academic year 2022-23.
- Under the scheme, the government has committed to providing Rs 3,000 per month to degree holders and Rs 1,500 per month to diploma holders who have been unable to secure employment in the last six months and are not pursuing higher studies.

India's First National Highway steel Road section on NH-66 Mumbai-Goa National Highway inaugurated

• Dr. V.K. Saraswat, Member (S&T), NITI AAYOG inaugurated India's First National Highway Steel Slag Road section on NH- 66 Mumbai-Goa National Highway. The Steel Slag Road Technology, developed by CSIR-Central Road Research Institute (CSIR-CRRI) is transforming the waste of steel industries into wealth and is helping the National Highways Authority of India (NHAI) to build stronger and ecofriendly national highways in the country.

Wholesale Price Index (WPI) Inflation Hits Nine-Month High At 0.73% In December 2023

- The wholesale price index (WPI)-based inflation came in at 0.73 per cent for December 2023, up from 0.26 in November, according to the data released by the Ministry of Commerce and Industry. WPI has continued its upward trajectory after returning to positive territory in November after seven months.
- Earlier in March, the WPI-based inflation was 1.34 per cent before falling to -0.92 per cent in April.Positive rate of inflation in December, 2023 is primarily due to increase in prices of food articles, machinery & equipment, other manufacturing, other transport equipment and computer, electronics & optical products etc.

Government Reduces Windfall Tax On Crude Oil Amid Global Economic Concerns

- In response to the evolving dynamics of the global oil market, the Indian government has decided to slash the windfall tax on domestically-produced crude oil, effective January 16. The tax, levied as the Special Additional Excise Duty (SAED), has been reduced from Rs 2,300 per tonne to Rs 1,700 per tonne.
- The move aims to address the challenges posed by soaring crude oil prices and is part of the government's fortnightly review mechanism based on average oil prices in the preceding two weeks. The reduction in windfall tax comes against the backdrop of concerns about weakened global economic conditions and an increase in crude inventories in the United States, contributing to a decline in crude prices.

New campus of National Academy of Customs, Indirect Taxes and Narcotics in Andhra Pradesh

- Prime Minister Narendra Modi will be on a two-day visit to Andhra Pradesh and Kerala. He

Himachal Pradesh Launches 'My School-My Pride' For Education Transformation



- Similipal is the only place where melanistic (black stripe) tigers are found in the wild. The safari is expected to boost tourism as tourists will now get to see the rare big cat.

Cabinet approved RS.8500 crores to promote coal / Lignite Gasification Projects under 3 categories

- The Union Cabinet approved a viability gap funding (VGF) scheme of ₹8,500 crore for coal gasification projects for public and private sector companies. The grant will be paid to the selected entity in two equal installments.
- The VGF will be given in three categories. One, for three projects of government-owned companies, for which a grant of ₹ 4,050 crore will be given. The selection of entities under category II and III shall be carried out through a competitive and transparent bidding process.

BRICS Group To Double In 2024 After Saudi, Iran, UAE, Egypt, Ethiopia Join Ranks

• Current members Brazil, Russia, India, China and South Africa in August invited six other nations to become part of their group, pairing some of the planet's largest energy producers



- with some of the biggest consumers among developing countries. Only Argentina declined the invitation after President Javier Milei, who took office this month, reversed his predecessor's membership bid.
- Established in 2009 as an informal alliance, the BRICS group (which was initiated by Russia) is aimed at providing a platform for its members to counter the dominance of the United States and its Western allies in the global order.

Strong Growth In GST Collections ,December 2023 Records ₹1.65-Lakh Crore

- In a significant economic development, Goods and Services Tax (GST) collections for December 2023 reached ₹1,64,882 crore, marking a notable 10.28% surge compared to the ₹1,49,507 crore collected in the same month the previous year.
- This accomplishment underscores the seventh consecutive month in the fiscal year where average GST collections have exceeded ₹1.6-lakh crore. Notably, November 2023 witnessed GST collections at ₹1,67,929 crore, contributing to the overall positive trend.

10th World Tamils Economic Conference & and Global Economic Summit to be held in Chennai

- The 10th World Tamils Economic Conference and Global Economic Summit will be held in Chennai on January 9 and January 10.Nearly 50 speakers are expected to present papers in various sessions, including the global economic situation opportunities and challenges; start-ups and innovative projects; funding and financial assistance; opportunities in healthcare projects and IT; communication and artificial intelligence, and women empowerment through education and entrepreneurship.
- The First World Tamils Economic Conference was held in Chennai 2009, the second was in Dubai 2011, third was in Chennai 2016, fourth was in Durban, South Africa 2017 and the Fifth was in Pondicherry 2018, again Sixth was in Chennai 2019, Seventh was virtual 2020, eighth was in chennai both virtual and physical.

South Korea launches 'workation' visa for foreigners

- South Korea has introduced a new visa for foreigners allowing them to visit the country on a working holiday or workation. The "workation" or "digital nomad" visa allows foreign nationals to visit South Korea on a working holiday.
- According to Yonhap News Agency, the "digital nomad" or "workation" visa will be given by South Korea's justice ministry to those having a work experience of over a year in one



industry and are eligible for remote work. The visa will also be allowed to the families of these employees.

Toy exports from India increased 239% over last 8 years

- Exports of toys from India increased 239 per cent over the last eight years to \$326 million in 2022-23 from \$96 million in 2014-15 while imports declined 52 per cent to \$159 million from \$332 million in the same period because of a combination of measures including import tariff increase and quality control, per a case study on the 'success story of made in India toys' carried out by IIM Lucknow on behalf of the Department for Promotion of Industry and Internal Trade (DPIIT).
- In the next eight years, around 12 per cent compounded annual growth rate is expected in the toy sector and exports are likely to increase to \$3 billion by 2028. Toys imports declined 52% from \$332 million to \$159 million in the same period. The study was conducted by IIM Lucknow on behalf of the Department for Promotion of Industry and Internal Trade (DPIIT).

MoU for several investments to be signed on second day of global investors meet in Tamil Nadu

- During the Global Investors Meet, discussions were held on climate change missions, circular economy, AI, and providing a robust environment for start-ups and SMEs. - The slaughter and sale of dogs for their meat is to become illegal in South Korea after MPs backed a new law. The legislation, set to come into force by 2027, aims to end the centuries-old practice of humans eating dog meat.
- Dog meat stew, called "boshintang", is considered a delicacy among some older South Koreans, but the meat has fallen out of favour with diners and is no longer popular with young people. Under the new law the consumption of dog meat itself will not be illegal.

India to chair UNESCO's world heritage committee for first time in July

- India is set to chair UNESCO's World Heritage Committee and host its 46th session in New Delhi from July 21 to 31, 2024, marking a historic milestone for our nation. Vishal V Sharma, India's Permanent Representative to UNESCO, announced this decision on January 9.
- The World Heritage Committee, comprising representatives from 21 member states, gathers annually to recognize global cultural and natural heritage. Their work contributes to the prestigious UNESCO World Heritage Sites list.

- Switzerland agreed to host a global peace summit on Ukraine at the request of Ukrainian President Volodymyr Zelenskiy. Neutral Switzerland has previously acted as a broker to resolve conflicts and could now help find a resolution for the war that began when Russia sent troops into Ukraine on Feb. 24, 2022.
- Zelenskiy, during a press conference in Bern alongside Swiss counterpart Viola Amherd, revealed that the peace summit's participants are yet to be finalized. However, he



emphasized the invitation to countries respecting Ukraine's sovereignty and territorial integrity, hinting at inclusivity.

Japan becomes 5th country to land a spacecraft on the moon



- Japan became the 5th country in history to reach the moon when one of its spacecraft successfully made a soft landing on the lunar surface. Japan follows the United States, the Soviet Union, China and India in reaching the moon.
- SLIM landed on the moon at about 12:20 a.m. Tokyo time.SLIM, which was aiming to hit a very small target, is a lightweight spacecraft about the size of a passenger vehicle.It was using "pinpoint landing" technology that promises far greater control than any previous moon landing.

Switzerland and India reach deal on FTA after 16 years of negotiations

- After 16 years of negotiations, Switzerland and India have finally reached a consensus on a
 free-trade agreement, as confirmed by Swiss Economy Minister Guy Parmelin, reported.
 Parmelin is heading the delegation of the European Free Trade Association (EFTA). Last

The world's tallest 721 feet Ram temple will be built in Perth, Australia

• Perth in Australia will soon be home to the world's tallest Ram temple - the colossal structure will be approximately 721 feet tall. Spearheaded by the ShriRam Vedic and Cultural Trust, the monumental project, estimated to cost around ₹ 600 crore, will be spread across 150 acres.



• Dr Harendra Rana, the deputy head of the Trust, revealed that the project extends beyond the conventional concept of a temple. The International ShriRam Vedic And Cultural Union (ISVACU) which is overseeing the project has envisioned the temple as a multifaceted hub encompassing cultural, spiritual, and community activities.

The body also announced that nine military figures had been removed from their positions in the NPC, according to Xinhua.

Justice BR Gavai Nominated as Chairperson of Supreme Court Legal Services Committee

- Supreme Court judge Justice BR Gavai has been nominated as the Chairman of the Supreme Court Legal Services Committee (SCLSC), replacing Justice Sanjiv Khanna the senior most judge of the top court after the Chief Justice of India (CJI).
- The Supreme Court Legal Services Committee is constituted under Section 3A of the Legal Services Authorities Act, 1987, with the aim of providing "free and competent legal services to the weaker sections of society" in cases under the jurisdiction of the Supreme Court.

Senthil Pandian C to be India's next ambassador to WTO



- The Indian government has named IAS officer Senthil Pandian as the ambassador to the World Trade Organisation (WTO) in Geneva. This appointment follows the conclusion of Brajendra Navnit's term as India's ambassador to the WTO on March 31, 2024. The decision was approved by the Appointments Committee of the Cabinet (ACC), entrusting Pandian, a 2002 IAS officer from the Uttar Pradesh cadre, with the responsibility for a three-year term from the date of assuming office.
- Senthil Pandian C is currently serving as the commissioner of excise in Uttar Pradesh. His extensive experience in administrative roles within the Indian bureaucracy positions him well to represent the country's interests on the global trade stage. As he takes charge, Pandian steps into a crucial role during a time of unprecedented economic challenges and shifting global trade dynamics.

Bhutan's Tshering Tobgay to become PM for second time

- Bhutanese voters have elected Tshering Tobgay to become Prime Minister for a second time after his party won nearly two-thirds of seats, the election commission said in results released on January 10. The party clinched almost a two-thirds majority, winning 30 seats of the 47 national assembly seats to return to power.
- The election was dominated by serious economic challenges that have called into question the Himalayan kingdom's long-standing policy of prioritising "Gross National Happiness" over growth. Prime Minister Narendra Modi of India, Bhutan's key trading partner, offered his "heartiest congratulations to my friend" Tobgay for winning the polls, according to a post on X, formerly Twitter.

Gabriel Attal appointed as France's new Prime Minister

- Gabriel Attal has been named next Prime Minister of France, as Emmanuel Macron aims to revive his presidency with a new government. Gabriel Attal is currently working as an education minister. Before Attal, the Socialist leader Laurent Fabius was the youngest French PM, appointed at the age of 37 by President François Mitterrand in 1984.
- At 34, he is the youngest Prime Minister in modern French history, outranking even Socialist Laurent Fabius who was 37 when he was appointed by François Mitterrand in 1984.Mr Attal replaces Élisabeth Borne, who resigned after 20 months in office.

Sheel Vardhan singh appointed as UPSC member

• In a significant development, Sheel Vardhan Singh, the former Director General of the Central Industrial Security Force (CISF), has been appointed as a member of the Union



- Public Service Commission (UPSC). The decision was conveyed through a personnel ministry order, marking a notable milestone in Singh's distinguished career.
- During his tenure as the Director General of CISF from November 2021 to December 2023, Singh played a pivotal role in providing visionary leadership that significantly enhanced security measures across the vital industrial sector. His strategic acumen and commitment to strengthening the nation's security infrastructure earned him recognition and respect within the organization.

Taiwan Elects Pro-Sovereignty William Lai in Historic Election, Further Straining China Ties

- Lai, the candidate of the ruling Democratic Progressive Party, won a tight race with 40.1% of the vote, beating out two rivals who favor closer ties with Beijing. A third consecutive presidential term for any party is unprecedented in Taiwan and indicates that, for at least a plurality of voters, antipathy toward mainland China outweighs growing discontent over the economy and other domestic problems.
- But as packed crowds of supporters reveled in the Democratic Progressive Party's win outside its headquarters here in Taipei, Lai struck a sober tone in his victory speech, seemingly mindful of the challenges facing him over the next four years, including the island's standoff with China, a divided legislature and an increasingly disaffected populace.

- In Guatemala City, the morning started off hopeful. Big groups of indigenous people came into the city on buses. Across the boulevards musicians played on stages, and kids carried balloons. An inauguration felt inevitable.

Crown Prince Frederik X becomes king of Denmark

- Denmark's King Frederik X has taken the throne after the abdication of his mother Queen Margrethe II, looking emotional as he waved to the thousands who gathered in the capital Copenhagen to witness the start of a new era.
- For many in Denmark, his mother Margrethe was the only monarch they had ever known. But her shock abdication, after more than five decades on the throne, paved the way for her son, the former crown prince, to succeed her.

Rameshbabu Praggnanandhaa Surpasses Viswanathan Anand to become India's number one Chess player

- As a result of this victory, Praggnanandhaa became only the second Indian after Vishwanathan Anand to defeat a reigning champion. He also overtook Anand to become India's new number one Chess player in terms of live ratings.
- Rameshbabu Praggnanandhaa, an 18-year-old chess prodigy from Chennai, achieved a
 historic milestone in his career by defeating World Champion Ding Liren from China. This
 significant victory occurred during the fourth round of the 2024 Tata Steel Chess
 Tournament held in Wijk aan Zee.

- India will serve as member of a FAO Fisheries Bureau on 'Capture Fisheries' for the first time in 57 years. India is one of the top fishing nations with over 28 million inland and marine fishers.

BANKING NEWS

RBI permits lending and borrowing of G-Secs

- The Reserve Bank of India (RBI) announced new guidelines on December 27, 2023, focused on lending and borrowing practices of government securities. The central bank aims to deepen the market for securities lending and borrowing and enhance the depth and liquidity of the Government Securities (G-Sec) market.
- Under newly issued guidelines, Government Securities (excluding Treasury Bills) issued by the central government are eligible for lending or borrowing through a Government Security Lending (GSL) transaction. Further, G-Secs, including Treasury Bills and state government bonds, can also be used as collateral in GSL transactions.

Women Secure 34% Share of Life Insurance Policies in Fiscal Year 2022-23

- India's Insurance industry is one of the premium sectors experiencing upward growth. This upward growth of the insurance industry can be attributed to growing incomes and increasing awareness in the industry. India is the fifth largest life insurance market in the world's emerging insurance markets, growing at a rate of 32-34% each year.
- In the fiscal year 2022-23, the number of life insurance policies issued to women reached 97.38 lakh, out of a total of 2.84 crore policies sold. Foreign Direct Investment (FDI) in the



industry under the automatic method is allowed up to 26% and licensing of the industry is monitored by the insurance regulator the Insurance Regulatory and Development Authority of India (IRDAI).

NPCI set to Introduce UPI for secondary market from Jan 1, 2024

- The National Payments Corporation of India (NPCI) is set to launch a Unified Payments Interface (UPI) feature for stock trading in the secondary market starting January 1, 2024. This initiative will start in its beta testing phase for the equity cash segment and aims to streamline trading and enhance security and profitability for investors.
- This UPI-based system involves blocking a specific amount for multiple debit transactions, enabling seamless trading in the stock market. Initially, in the beta phase, the service is available for a limited set of pilot customers before its full-scale launch.

RBI Issues Notification on Reporting Requirements for Resident Individuals under the Liberalised Remittance Scheme (LRS)

- RBI Issues Notification on Reporting Requirements for Resident Individuals under the Liberalised Remittance Scheme (LRS). The Reserve Bank of India (RBI) notified regarding the Liberalised Remittance Scheme (LRS) for Resident Individuals- Reporting of monthly return and daily transactions.
- It has now been decided that the submission of both returns through the XBRL site will be discontinued and shifted to the Centralised Information Management System (CIMS), which is the Bank's new data warehouse.

InCred's lending business turns unicorn after raising \$60 m in Series D round

- InCred Financial Services Ltd (InCred Finance), the lending arm of financial services firm InCred Group, has raised ₹500 crore in its Series D round of funding from new and existing investors.
- Following the fresh capital infusion, InCred has been valued at \$1.04 billion and has become the second company to gain unicorn status this year.InCred Financial Services was formed by the merger of KKR India Financial Services Ltd and the erstwhile InCred Financial.

UPI Ends 2023 With Record Transactions Worth ₹18-Lakh Crore, Up 42% Y-O-Y

• Unified Payments Interface (UPI) ended 2023 at a high, recording over 1,200 crore transactions worth more than ₹18-lakh crore in December, a peak for both the transaction count and value.Over 11,765 UPI transactions worth ₹182.2-lakh crore were processed in



- 2023, up 59 per cent in terms of volume and 45 per cent in terms of value compared with 2022, as per data by the National Payments Corporation of India (NPCI).
- Transactions worth ₹18.23-lakh crore were processed during December, significantly higher than the previous high of ₹17.40-lakh crore in November. In percentage terms, the value of transactions was 4.8 per cent higher on the month and 42 per cent on year.

FinMin Allows 30th Tranche Of Electoral Bonds

- The government has approved the issuance of the 30th tranche of electoral bonds that will open for sale. Electoral bonds have been pitched as an alternative to cash donations made to political parties as part of efforts to bring transparency to political funding. General elections are due later this year as the term of the 17th Lok Sabha is coming to an end.
- State Bank of India (SBI), in the XXX Phase of sale, has been authorised to issue and encash Electoral Bonds through its 29 Authorised Branches w.e.f. January 2 to January 11, 2024," the finance ministry said in a statement. Electoral bonds are encashed by an eligible political party only through a bank account with the authorised bank. SBI is the only authorised bank to issue electoral bonds.

RBI Reports Indian Banks Achieve Decadal High in Asset Quality Improvement

- The Gross Non-Performing Assets (GNPA) ratio of Indian scheduled commercial banks (SCBs) went on improving in the second quarter of this financial year, dropping to a fresh decadal low, according to the Reserve Bank of India's (RBI's) report titled 'Trend and Progress of Banking in India'.
- "The improvement in asset quality, measured by GNPA ratios, that began in 2018-19 continued during 2022-23. The GNPA ratio of SCBs fell to a decadal low of 3.9% at end-March 2023 and further to 3.2% at end-September 2023," the RBI said in the report which was released. As per the report, the Indian scheduled commercial banks (SCBs) Gross Non-Performing Assets (GNPA) ratio improved in the second quarter of this financial year.

RBI Prolongs Payments Infrastructure Development Fund Scheme By 2 Years Till December 2025

• The Reserve Bank of India (RBI) announced its decision to extend the Payments Infrastructure Development Fund (PIDF) for two years up to December 31, 2025. The Scheme was operationalized by the RBI in 2021 for three years (extendable up to 2 years) to encourage deployment of payment acceptance infrastructure in India.



• It includes physical Point of Sale (PoS) terminals, Quick Response (QR) codes, in tier-3 to tier-6 centers, North Eastern states and Union Territories (UTs) of Jammu & Kashmir and Ladakh. To strengthen the payment acceptance infra by including 30 lakh touch points, which includes 10 lakh physical and 20 lakh digital payment devices every year.

Muthoot FinCorp Secures ₹200 Crore through Private Placement of NCDs from SBI

- Muthoot FinCorp, the flagship company of Muthoot Pappachan Group (Muthoot Blue), has announced ₹200 crore investment by State Bank of India (SBI) in the non-convertible debentures (NCDs) under private placement with a face value of ₹1 lakh for each NCD.
- The maturity/tenure options of this issue is five years with half yearly being the frequency of the interest payment. The secured issued NCDs is rated as AA-/stable by CRISIL and listed on the debt market segment of BSE, Muthoot FinCorp said in a statement.



Record 8.18 crore Income Tax Returns filed so far in current financial year

- India has witnessed a substantial surge in the number of Income Tax Return (ITR) filings, setting a new record at 8.18 crore filings by December 31, 2023. This marks an increase of 9 per cent from the 7.51 crore returns filed by the same time in the previous year.
- During the same period, a total of 1.60 crore audit reports and other forms were filed, surpassing the 1.43 crore filings in the corresponding period of the preceding year. To encourage taxpayers to file their ITRs and forms early, over 103 crore outreaches were made through targeted e-mail, SMS and other creative campaigns.

REC Limited signs MoU with Rail Vikas Nigam Limited, to Finance Multi-Modal Infrastructure Projects up to Rs. 35,000 crores over next 5 Years

• REC Limited has entered into an MoU with Rail Vikas Nigam Limited (RVNL) to finance up to Rs. 35,000 Crores for Infrastructure Projects to be executed by RVNL over the next 5



- years. These projects constitute multi-modal logistics hub projects, rail infrastructure projects, road, port, and metro projects where RVNL has forayed into.
- RVNL is primarily undertaking Railway projects and has also made forays into road, port, irrigation and metro projects, many of which have forward and/or backward linkages with Railway infrastructure one way or the other.

White-Label ATM Expansion Propels 3.5% Growth in Total ATMs for 2022-23

- India must install at least 5-10 lakh additional automated teller machines (ATMs) to improve digital financial inclusion, said experts at a webinar organised by The Dialogue, a prominent tech policy think-tank, on September 22, 2023. They emphasised the critical role of ATMs in bridging the urban-rural divide and promoting economic growth.
- ATMs complement digitisation efforts and serve as vital tools to boost financial inclusion in remote communities. Public Sector Banks (PSBs) continue to dominate the ATM landscape, with a notable increase from 75,653 in 2022 to 78,777 in 2023 for on-site ATMs.

RBI permits ICICI Pru Mutual Fund to acquire 9.95% stake in Karur Vysya Bank

- Reserve Bank of India has accorded approval to ICICI Prudential Asset Management Company Ltd (ICICI AMC) for acquiring up to 9.95 per cent stake in the bank.RBI accorded the approval subject to conditions on Thursday, Federal Bank said in a regulatory filing.
- The approval granted by the Reserve Bank of India (RBI) is subject to the compliance with the relevant provisions of the Banking Regulation Act, 1949, RBI's Master Direction and Guidelines on Acquisition and Holding of Shares or Voting Rights in Banking Companies dated January 16, 2023. Meanwhile, RBI also accorded approval to ICICI AMC to acquire 9.95 per cent stake in RBL Bank and Equitas Small Finance Bank.

Reserve Bank of India plans to tighten dividend declaration criteria for banks

- The Reserve Bank of India (RBI) has proposed new rules of dividend payout for domestic and overseas banks operating in India. The proposed rules for dividend payout by banks will be effective from the fiscal year 2024-25 onwards.
- The RBI has invited public feedback on the proposed rules, and the deadline for submission is 31 January 2024. Banks with an NNPA (Net Non-Performing Asset) ratio exceeding 6% and a Capital Adequacy Ratio (CAR) below 11.5% are prohibited from declaring dividends.

RBI gives clarity to 'politically exposed persons' term to meet FATF norms

• The Reserve Bank of India (RBI) has updated Know Your Customer (KYC) norms for politically exposed persons (PEPs) who transact with regulated entities (REs), seeking to



- comply with the recommendations of intergovernmental organisation Financial Action Task Force (FATF),
- PEPs are individuals entrusted with prominent public functions by a foreign country, including the heads of states/governments, senior politicians, senior government or judicial or military officers, senior executives of state-owned corporations and important political party officials.

Narayana Health gets IRDAI nod to launch health insurance business

- Narayana Health has received approval from the Insurance Regulatory and Development Authority of India (IRDAI) to venture into the health insurance business in India.
- The company operates one of the largest hospital chains, known by the brand name Narayana Hospital. With this approval, the count of Standalone Health Insurance Companies (SAHI) will increase from 5 to 6.

Tata Pay Secures Payment Aggregator License from RBI

- In a significant development, Tata Pay, the digital payments app under Tata Digital, has been granted a payment aggregator (PA) license by the Reserve Bank of India (RBI). This license positions Tata Pay among industry leaders such as Razorpay, Cashfree, and Google Pay, enabling it to efficiently handle ecommerce transactions within its subsidiary entities.
- Similar licenses were also obtained by other players like DigiO, a Bengaluru-based identity verification startup supported by Groww, allowing them to integrate payment services with their digital identification solutions.

RBI Introduces Stricter Regulations for Short-Term Commercial Papers and Non-Convertible Debentures

- The Reserve Bank of India (RBI) has tightened rules for the issuance of short term Commercial Papers (CPs) and Non-Convertible Debentures (NCDs), with an initial maturity of up to one year. As per the revised norms, CPs and NCDs issued from April 1 onwards will have a minimum denomination of Rs 5 lakh and in multiples of Rs 5 lakh thereafter.
- The new norms are effective from April 1, 2024, and include six key changes. Non-residents are eligible to invest in CPs and NCDs to the extent permitted under FEMA or the rules framed under.

Raksha Mantri approves proposal to launch group Insurance Scheme for Casual Paid Labourers engaged by BRO



- Raksha Mantri Shri Rajnath Singh has approved a proposal to launch a Group (Term) Insurance Scheme for Casual Paid Labourers (CPLs) engaged by Border Roads Organisation/General Reserve Engineer Force for the ongoing project works. This scheme will provide the insured value of Rs 10 lakh as an insurance in any kind of death to CPLs family/Next of Kin.
- This scheme will serve as a social security and welfare measure to the CPLs working in remote and far-flung areas of the nation. It will go a long way in securing the livelihoods of their families

RBI cancels licence of Hiriyur Urban Co-op bank with immediate effect

- It has canceled the license of The Hiriyur Urban Co-operative Bank citing weak financial condition. The survival of the bank is detrimental to the interests of its depositors as the bank, with its current financial position, would be unable to make full payments to its existing depositors.
- According to the data presented by the bank, 99.93 percent of the depositors are entitled to
 receive the full amount of their deposits from DICGC. According to the release, it has been
 said that till September 30, 2023, DICGC has already paid Rs 224.53 lakh of the total
 insured deposits based on the wishes received from the respective depositors of the bank.

Defense Minister Sanctions Insurance Scheme for BRO Workers

- For the benefit of casual labourers employed by the Border Roads Organisation (BRO) for constructing roads and tunnels in harsh terrain and border areas, the Defence Ministry has sanctioned a group insurance scheme.
- This is the second set of welfare measures for such workers announced by the ministry in the last five months. The insurance cover, the ministry says, is likely to serve as a social security and welfare measure for the labour force employed in infrastructure project works. Defence Minister Rajnath Singh approved the scheme that will provide an insured sum of Rs 10 lakh to the deceased labourer's family or next of kin in case of a fatal mishap on the job.

State bank of India has introduced the Green Rupee Term Deposit

• State Bank of India (SBI), the country's largest Bank has launched a special fixed deposit (FD) scheme. SBI Green Rupee Term Deposit (SGRTD) has been launched to mobilise funds to support environment-friendly initiatives and projects, thereby fostering the growth of a green finance ecosystem in India, as per the release shared by the bank.



• Recently, the State Bank of India (SBI) launched the SBI Green Rupee Term Deposit (SGRTD). The SGRTD is a deposit scheme that aims to raise funds for environmentally-friendly initiatives and projects. The scheme is open to NRIs, non-individuals, and resident individuals. The SGRTD has tenors of 1,111 days, 1,777 days, and 2,222 days. The SGRTD offers flexible tenors.

- SmartFin facilitates digital SCF loans for dealers and suppliers of corporate clients, enabling them to achieve their strategic business objectives, that includes working capital efficiency, market expansion, sales acceleration, and strengthening supply chain partnership.

World Bank keeps India's FY25 GDP growth estimate unchanged at 6.4%

- The World Bank has maintained its economic growth projection for India in the fiscal year 2024-25 at 6.4 percent. This is attributed to factors like high food inflation and diminishing pent-up demand. The unchanged projection is attributed to factors such as strong domestic demand, increased public infrastructure spending, and robust growth in private-sector credit.
- In its biannual 'Global Economic Prospects' report, the World Bank said India was likely to maintain the fastest growth rate among the world's largest economies, but its post-pandemic recovery was expected to slow, with estimated growth of 6.3 per cent in FY24, before recovering gradually to 6.5 per cent in FY26.

Reserve Bank of India imposes monetary penalty on Punjab and Sind Bank

- The Reserve Bank of India (RBI) has imposed a monetary penalty of ₹1 crore on Punjab and Sind Bank for non-compliance with certain directions issued by RBI on 'Loans and Advances Statutory and Other Restrictions'.
- This penalty has been imposed in the exercise of powers vested in RBI conferred under the provisions of Section 47 A (1) (c) read with Sections 46 (4) (i) and 51(1) of the Banking Regulation Act, 1949. This action is based on deficiencies in regulatory compliance and is not intended to pronounce upon the validity of any transaction or agreement entered into by the bank with its customers.



EPFO Removes Aadhaar as Valid Date of Birth Proof

- The UIDAI has clarified that while Aadhaar serves as unique identification proof, it does not qualify as evidence of date of birth under the provisions of the Aadhaar Act, 2016. The circular stressed that this decision aligns with the directives of Table-B of Annexure-1 of the Joint Declaration SOP issued earlier. The decision received approval from the Central Provident Fund Commissioner (CPFC).
- UIDAI's circular referenced the Aadhaar Act of 2016 and the corresponding regulations governing the enrolment and update procedures, explicitly stating that Aadhaar cannot be considered valid proof of date of birth. This aligns with the stance presented in the office memorandum issued on December 20, 2018, reiterating that Aadhaar is not proof of date of birth.

Power Minister RK Singh Launched POWERGRID Vishram Sadan in Bengaluru

- POWERGRID Vishram Sadan was inaugurated by Sh. R.K. Singh, Hon'ble Union Minister for Power, New and Renewable Energy, Govt. of India in virtual presence of Dr. Mansukh L Mandaviya, Hon'ble Minister of Health and Family Welfare, Chemical and Fertilizer presence of Sh. K J George, Hon'ble Minister of Energy, Sh. Tejasvi Soorya, Hon'ble MP, Bengaluru South, Dr. Yatindra Dwivedi, Director (Personnel) POWERGRID, Dr. Partima Murthy, Director, NIMHANS, Bengaluru and senior officials from POWERGRID.
- Indian power sector is ready to meet the growing demand of Power. The demand of power is increased by 70% in the last 9 years. The Minister was addressing the audience after inaugurating the Vishram Sadan by Power Grid Corporation of India Ltd at National Institute of Medical Health and Neurosciences NIMHANS campus in Bengaluru today. He asserted that no other country had experienced such a huge demand.

India, Russia ink pacts on construction of future power units of Kudankulam nuclear plant

• India and Russia signed the agreement on the construction of future power units of the Kudankulam nuclear plant. Agreements have also been signed in the areas of medicines, pharmaceutical substances and medical devices.



• The Kudankulam nuclear power plant is being constructed in Tamil Nadu with the technical assistance of Russia. The construction started in March 2002. The Kudankulam nuclear power plant's first generating unit has been continuously running at its 1,000 MW design capacity since February 2016.

Exercise desert cyclone started on 2 january 2024 in Rajasthan

- Ministry of External Affairs, potential areas of bilateral cooperation in the defence field are
 the production and development of defence equipment; joint exercises of armed forces,
 particularly naval exercises; sharing of information on strategy and doctrines; technical
 cooperation in respect of Intermediate Jet Trainer etc.
- In recent times, the collaboration in defence between the two nations has seen significant
 enhancement, particularly in defence training, the supply of defence inventory, and the
 implementation of regular exchange programs. The joint drills under 'Desert Cyclone 2024'
 will aim to enhance interoperability by learning and sharing best practices in urban
 operations.

Reliance Jio and IIT-Bombay Collaborate to Develop 'BharatGPT' AI for India

- Reliance Jio Infocomm, an Indian telecom operator in India, is set to launch a groundbreaking initiative in collaboration with the Indian Institute of Technology (IIT) Bombay the 'Bharat GPT' program.
- Announced by Akash Ambani, the chairman of Reliance Jio, this program aims to leverage the power of large language models and generative artificial intelligence (GPT) to transform various sectors in the country. The Bharat GPT program is part of Jio's broader vision, known as "Jio 2.0". Its main aim is to create a comprehensive ecosystem of development.

Russia and NASA Extend Joint ISS Flights Until 2025

- Russian and US space agencies have agreed to keep working together to deliver crews to the
 International Space Station (ISS) until at least 2025, Russian corporation Roscosmos.
 Russia's space state agency Roscosmos said that a cross-flight programme with NASA to the
 International Space Station (ISS) had been extended until 2025, Interfax news agency
 reported.
- The International Space Station Program brings together international flight crews, multiple launch vehicles, globally distributed launch and flight operations, training, engineering, and development facilities, communications networks, and the international scientific research community.



IIT Madras targets incubating 100 startups across various sectors in 2024

- Indian Institute of Technology Madras (IIT Madras) is targeting incubating at least 100 start-ups across various sectors next year, in 2024. Sharing the institute's targets for 2024, V. Kamakoti, Director, IIT Madras, said, "We are looking at closing this financial year ending March 31, 2024 with 366 patents. We will try our best to see one patent a day.
- Kamakoti said the institute is working hard towards maintaining the number 1 ranking in the National Institutional Ranking Framework (NIRF). Hopefully, we are also looking to move to higher rankings in World Rankings as well. We want to start a couple of new courses in IITM Zanzibar.

Kerala Introduces K-Smart Tech Solution for Streamlining Local Self-Government Services

- Aimed at making available all services of local self-government institutions over a uniform digital platform, Kerala has introduced K-Smart (Kerala Solutions for Managing Administrative Reformation and Transformation), the first of its kind project in the country.
- It is for the first time that a system that makes available the entire gamut of services of a department in a single click is being introduced in the country. Initially, K-Smart will be operational in corporations and municipalities and later will be rolled out in grama panchayats as well.

NASA Reinitiates Spacecraft Mission to Study 'God of Chaos' Asteroid Apophis

- The National Aeronautics and Space Administration (NASA) has relaunched a spacecraft to study asteroid Apophis. The former OSIRIS-REx spacecraft has now been renamed OSIRIS-APEx. OSIRIS-REx had carried out a seven-year journey to bring Earth a sample of asteroid Bennu.
- The National Aeronautics and Space Administration (NASA) has relaunched the OSIRIS-REx spacecraft to intercept the 'God of Chaos' asteroid Apophis as it approaches Earth's orbit. The spacecraft has been renamed OSIRIS-APEX (Origin, Spectral Interpretation, Resource Identification, and Security–Apophis Explorer).

Ratle hydroelectric project to power rajasthan for 40 years

 Ratle Hydro Electric Power Corporation Limited (RHPCL), a joint venture company of NHPC Limited and Jammu and Kashmir State Power Development Corporation (JKSPDC), has entered into a Power Purchase Agreement (PPA) with Rajasthan Urja Vikas and IT



- Services Limited, for offtake of power generated from 850 MW Ratle Hydroelectric Project, Kishtwar in the union territory of Jammu & Kashmir.
- The agreement has been signed for offtake of power for a period of 40 years from the Commercial Operation Date (COD) of the project and as per power allocation to be notified by Ministry of Power, Govt. of India. The signing ceremony took place in Jaipur, with the presence of senior officials from RHPCL and Rajasthan Urja Vikas and IT Services Limited. This collaboration signifies a strategic initiative to enhance the energy landscape, fostering sustainable power solutions for Rajasthan.

Israel Approves \$3.2 Billion Grant to Intel for Construction of \$25 Billion Chip Plant

- Israel's government agreed to give Intel Corp a \$3.2 billion grant for a new \$25 billion chip plant it plans to build in southern Israel. The chip plant will be an expansion of Intel's existing Kiryat Gat site.
- The news comes as Israel remains locked in a war with Palestinian militant group Hamas in the wake of the Oct. 7 Hamas attack on Israel. It also is a big show of support by a major U.S. company and a generous offer by Israel's government at a time when Washington has increased pressure on Israel to take further steps to minimize civilian harm in Gaza.

ISRO's first Sun mission successfully injected into final orbit

- Positioned around 1.5 million kilometres from Earth, Lagrange Point 1 is a unique location in space where the gravitational forces between the Sun and Earth are in a delicate equilibrium. The L1 point is about 1% of the total distance between the Earth and the Sun. The Sun's extreme temperatures make a "touchdown" impossible.
- A satellite placed in the halo orbit around the L1 point has the major advantage of continuously viewing the Sun without any occultation/eclipses. This will provide a greater advantage of observing the solar activities and their effect on space weather in real-time.

Indian navy reduced 21 crew members of merchant ship MV Lila Norfolk, including 15 Indians, from pirates off the Somalia coast

- The Indian Navy's elite marine commandos successfully rescued 21 crew members, including 15 Indians, from the Liberian-flagged vessel MV Lila Norfolk on January 5, 2024. The action was a rapid response to an attempted hijacking in the North Arabian Sea.
- The Indian Navy's marine commandos present onboard the mission deployed warship boarded the merchant vessel and have carried out the sanitisation operation."MV Lila



Norfolk sent a message on the United Kingdom Maritime Trade Operations (UKMTO) portal indicating that five to six unknown armed personnel boarded the vessel.

ArcelorMittal partners with IIT Madras to create Hyperloop facility in TN

- Steel giant ArcelorMittal has partnered with the Indian Institute of Technology, Madras to build "Asia's first" Hyperloop test track facility. ArcelorMittal is collaborating with the IIT Madras's Hyperloop Technology teams Avishkar Hyperloop, a student team, and TuTr Hyperloop, a startup incubated in IIT Madras, for the project.
- The companies, ArcelorMittal and ArcelorMittal Nippon Steel India (AM/NS), are providing foundational steel materials as well as engineering, design, and project management expertise to support the construction of Asia's first Hyperloop test track at the 163-acre Discovery campus of IIT Madras, located at Thaiyur on the outskirts of Chennai.

Tata Motors introduces 1st pure Electric Vehicle architecture called 'acti.ev'

- Tata Passenger Electric Mobility (TPEM) has launched its first advanced Pure EV architecture, acti.ev, and the Punch.ev, the first product based on this architecture. The Punch.ev can now be booked at Tata Motors showrooms and Tata.ev stores for a payment of ₹21.000.
- Tata Motors introduced the first pure electric vehicle (EV) architecture called 'acti.ev', which will underpin its future portfolio of EVs such as Punch, Sierra, Harrier and Curvv. Tata Motors holds more than 80% share in the electric car market.

HFCL bags Rs 1,127 cr order to transform BSNL's Optical Transport Network

- It has secured a Rs 1,127 crore order from Bharat Sanchar Nigam Ltd (BSNL) aimed at transforming the Optical Transport Network (OTN) infrastructure across the state-owned telco's pan India network.
- HFCL's comprehensive network upgrade will not only cater to the requirements of enterprise and FTTH/broadband services but also position BSNL for the future with the seamless launch of 4G services and the anticipation of 5G services in the coming years.

6.Indian Navy's Elite Marine Commandos Effectively Rescue 21 Crew Members, Including 15 Indians, from MV Lila Norfolk

 Indian Navy rescued all 21 crew members, including 15 Indians, onboard the distressed cargo ship 'MV Lila Norfolk' off Somalia coast. The Navy rushed its warship INS Chennai



- and deployed maritime operations after a distress signal from the cargo ship signalled the hijacking. The Navy's elite Marine Commandos (Marcos), conducted sanitisation operations on the vessel and confirmed the absence of hijackers.
- Naval warship INS Chennai, a navy destroyer, that was diverted from its anti-piracy patrol, launched its helicopter and issued warning to pirates to abandon the hijacked vessel. The hijacking was reported by the UK Maritime Trade Operations (UKMTO), a British military organisation that tracks movements of various vessels in strategic waterways.

India on top of medals table in Asian Shooting Championship in Jakarta with 07 Gold, 06 Silver, and 06 Bronze medals

- Media SAIIn Women's shooting, Rhythm Sangwan bagged the Bronze medal in the 25-meter Pistol event at the Asian Shooting Championship in Jakarta, Indonesia. With this medal, Rhythm confirmed the 16th Paris Olympic quota for the Indian shooting contingent.
- Also, this is the sixth Paris quota in the pistol events for India and the second in women's 25m Pistol. Rhythm ended the tournament with an impressive performance collecting a total of five medals, 1 gold, 2 silver, and 2 bronze medals.

India Navy to host MILAN 24 excercise in Visakhapatnam

- The MILAN exercise, initiated in 1995 as part of India's 'Look East policy,' has evolved into a biennial showcase of naval prowess and international collaboration. Following the success of the 11th edition held in Visakhapatnam in February-March 2022, organized under the Eastern Naval Command with the theme 'Camaraderie-Cohesion-Collaboration,' the upcoming edition marks a continuation of this tradition.
- This phase is designed to showcase the naval capabilities of the participating nations, highlighting their dedication to ensuring maritime security in the region. MILAN 24 underscores India's commitment to nurturing partnerships, exchanging ideas, and collectively enhancing maritime security.

Tamil Nadu may get four new Biodiversity Heritage sites

- There are several attractions in Arittapatti village but the most notable geographical feature is the chain of seven barren granite hillocks. This rocky landscape surprisingly supports a total of 72 lakes, 200 natural springs and three check dams. One of these lakes, Anaikondan Lake, dates back to the 16th century Pandya kingdom.
- Biodiversity heritage sites are biological areas with unique and ecologically fragile ecosystems comprising rare and threatened species. These kinds of areas are usually home to



important species that are not only endemic or endangered but can also be either keystone species, flagship species or umbrella species.

IISC Bengaluru develops heat tolerant vaccine against current strains of SARS-COV-2

- A heat-tolerant vaccine developed by the Indian Institute of Science (IISc) researchers to be
 effective against all current strains of SARS-CoV-2 besides having the potential to be
 quickly adapted for future variants as well.
- The vaccine candidate has been designed by genetically engineering a domain of the surface spike glycoprotein of SARS-CoV-2, called the Receptor Binding Domain (RBD), which plays a key role in facilitating viral entry and infection. Most of the neutralising antibodies produced by our body target the RBD.

Navy chief formally receives Drishti -10 long endurance UAV

- Maritime Domain Awareness (MDA) is extremely challenging for the Indian Navy since the Indian Ocean Region (IOR) accounts for one of the busiest maritime traffic regions of the world. The IOR sea lines are critical in bringing prosperity to many nations in the region. With the growth of the Chinese Navy, the presence of Chinese submarines and Underwater Unmanned Vehicles (UUV) have increased in the South China Sea and the Indian Ocean.
- Indian Navy is abreast with similar technology induction in many domains. The Navy had
 inducted the ship command and control system in the mid-eighties and developed an
 indigenous data link akin to Link 11 for networking warships and aircraft for Command,
 Control, Communications and Information (C3I) operations. The Navy has also acquired
 Unmanned Aerial Vehicles (UAV)s in the mid-nineties from Israel for long-range
 surveillance.

- In a historic move, the Indian Navy and Royal Thai Navy (RTN) joined forces for the maiden bilateral exercise named 'Ex-Ayutthaya' in December 2023. This maritime collaboration, symbolizing the invincible spirit, holds profound significance as it connects the ancient cities of Ayodhya in India and Ayutthaya in Thailand, reflecting shared historical narratives and rich cultural ties dating back centuries.
- In a landmark move, the Indian Navy and Royal Thai Navy conducted the inaugural 'Ex-Ayutthaya' naval exercise, signifying an unbreakable connection between the ancient cities of Ayodhya and Ayutthaya.

First human vaccine trials for deadly Nipah virus

- In a groundbreaking initiative, researchers at the University of Oxford in the United Kingdom have commenced the first-in-human vaccine trials for the deadly Nipah virus. This initiative is a significant step forward in addressing the severe impact of the virus on various Asian countries, including India. The trials will be conducted on 51 individuals aged 18 to 55 and are led by the Oxford Vaccine Group.
- The experimental vaccine, named ChAdOx1 NipahB, aims to combat the Nipah virus, a highly lethal disease with a fatality rate of approximately 75%. The Nipah virus has been



responsible for outbreaks in several Asian countries, such as Singapore, Malaysia, Bangladesh, and India. Notably, a recent outbreak occurred in Kerala in September of the previous year.

TCS ranked second most valuable IT brand in Global list

- Accenture, Tata Consultancy Services (TCS), and Infosys have continued to up their brand value and dominance in the IT industry, according to the latest Brand Finance 2024 report. This is despite disruptions caused by newer technologies and a tepid growth environment. The three IT services giants topped the list of world's most valuable IT services brands.
- Accenture remains the world's most valuable IT services brand, with a brand value of \$40.5 billion, representing a 1.6% increase from the previous year, according to an ET report quoting Brand Finance 2024 report.

North Korea conducts 'underwater nuclear weapons system' test

- North Korea informed it has carried out a test of its "underwater nuclear weapons system" in response to drills by the US, South Korea and Japan this week. The underwater drone, which supposedly can carry a nuclear weapon, was tested off the east coast, state media stated.
- South Korea called the reported tests a "provocation". The North has claimed tests of its "Haeil-5-23" system before, but the latest incident comes as the North has ramped up military action in recent weeks.

Union Minister Hardeep Singh Puri launches first pilot project to make jet fuel from alcohol in pune

- The first pilot technology project to make jet fuel from alcohol was inaugurated by Union Petroleum and Natural Gas Minister Hardeep Singh Puri in Pune. This project will produce sustainable biological aviation fuel or SAF. This pilot project has been set up in the research and development department of Praj Udyog Group in Pirangut Industrial Estate near Pune.
- Pramod Chaudhary, President of Praj, along with officials of Indian Oil and other oil
 companies were present for the inauguration program. There is a huge demand for this
 bioaviation fuel in the global market, and it is a big challenge to provide the necessary raw
 materials for it.

Tourism Ministry to organize annual event "Bharat Parv" from 23rd to 31st January

• The Ministry of Tourism, Government of India is set to organize the nine-day annual mega event "Bharat Parv" at the Lawns and Gyan Path in front of Red Fort, Delhi as part of the



- Republic Day Celebrations. Being held since 2016, this year it is being celebrated from 23rd 31st January 2024.
- The highlights of the mega event are the Republic Day Parade tableaux, dynamic cultural performances by the Zonal Cultural Centres and engaging presentations by cultural troupes from various States and Union Territories, food stall representing all the States and UTs, handicraft and handloom display and enthusiastic performances by the Armed Forces Band. The event is open to the public and entry is free.

SpaceX Launches Ax-3 Mission to ISS with First Turkish Astronaut Onboard

- In a historic event, SpaceX successfully launched the Ax-3 mission to the International Space Station (ISS) from NASA's Kennedy Space Center on January 18. The Crew Dragon capsule, named "Freedom," was propelled into space atop a Falcon 9 rocket, marking the third mission organized by Houston-based Axiom Space.
- The Ax-3 mission, led by former NASA astronaut Michael López-Alegría, boasts a diverse crew. Alongside mission pilot Walter Villadei and European Space Agency astronaut Marcus Wandt, it includes Alper Gezeravcı, Turkey's inaugural astronaut. Axiom highlights this mission as "the first all-European commercial astronaut mission" to the ISS.

Cameroon starts world's first malaria program for children

- Cameroon will be the first country to routinely give children a new malaria vaccine as the shots are rolled out in Africa. The country will be the first to routinely give children a new malaria vaccine, aiming to vaccinate about 250,000 kids this year and next year.
- The Central Africa nation hopes to vaccinate about 250,000 children this year and next year. Gavi said it is working with 20 other African countries to help them get the vaccine and that those countries will hopefully immunize more than 6 million children through 2025.

Securities and Exchange Board of India Permits Short-Selling for Investors Across Categories & Restricts Naked Short-Selling

- Investors across all categories will be allowed for short selling, but naked short selling will not be permitted. The market regulator also said all stocks that trade in the futures and options (F&O) segment are eligible for short selling.
- All investors would be required to mandatorily honour their obligation of delivering the securities at time of settlement. The Securities and Exchange Board of India (SEBI) has announced that investors across all categories will be allowed to engage in short-selling, with the restriction that naked short-selling will not be permitted.



India-Kyrgyzstan Joint Special Forces Exercise 'Khanjar' commences in Himachal Pradesh

- The 11th edition of the India-Kyrgyzstan Joint Special Forces Exercise 'Khanjar' commenced at the Special Forces Training School in Bakloh, Himachal Pradesh. The exercise, scheduled from January 22 to February 3, involves joint training between the special forces of India and Kyrgyzstan.
- According to an official release from the Ministry of Defence, the ongoing India-Kyrgyzstan
 Joint Special Forces Exercise 'Khanjar' is providing a valuable opportunity for both nations
 to strengthen defense ties while jointly addressing international concerns related to terrorism
 and extremism.

Iran successfully launches Sorayya satellite in orbit

- Iran has achieved a significant milestone in its space program with the successful launch and operation of its domestically-developed satellite, Soraya. The Soraya, which was launched into orbit approximately 750 kilometres above Earth's surface, has transmitted its first signal back to Earth.
- The U.S. intelligence community's 2023 worldwide threat assessment stated that the development of satellite launch vehicles "shortens the timeline" for Iran to develop an intercontinental ballistic missile because it uses similar technology.

Serum Institute of India joins global network to boost production of affordable outbreak vaccines

- The world's largest vaccine manufacturer, the Serum Institute of India Pvt. Ltd (SII), is joining a growing CEPI network of vaccine producers in the Global South to support more rapid, agile, and equitable responses to future public health disease outbreaks.
- The addition of SII to the CEPI manufacturing network will be a significant boost to vaccine
 production efforts in Global South regions and will mean the world is better prepared to
 achieve the 100 Days Mission to develop new vaccines against known or novel infectious
 diseases within three months of a pandemic threat being recognised.

Vijay Raghavan panel expressed concern in a report on the functioning of DRDO

• The Ministry of Defence in India has taken a significant decision to undertake a comprehensive revamp of the Defence Research and Development Organisation (DRDO). Long recognized for its delayed projects and cost overruns, the DRDO is now set to undergo a transformation to enhance its technological advancements beyond the missile program.



• In 2014, Prime Minister Narendra Modi inaugurated the Vadodara bus station, marking a significant milestone in modernizing public transportation which stands as the biggest bus stand in India as of 2024. With an expenditure of nearly 114 crores, this five-story structure accommodates 30,000 passengers daily, facilitating travel on 800 buses. The terminal also boasts a spacious commercial complex housing around 400 retail shops.

NATO's largest military exercise 'Steadfast Defender 2024' begins after the cold war

- NATO did not mention Russia by name in its announcement. But its top strategic document identifies Russia as the most significant and direct threat to NATO members' security. The exercise comes at an important moment after Russia's invasion of Ukraine started the deadliest war on European soil in more than 70 years.
- More than 50 ships from aircraft carriers to destroyers will take part, as well as more than 80 fighter jets, helicopters and drones and at least 1,100 combat vehicles including 133 tanks and 533 infantry fighting vehicles.

Indian Navy to set up second VLF communication station in Telangana

- The Telangana government has transferred 1,174 hectares of forest land at Dammaigudem forest area in Vikarabad district for the Indian Navy's Very Low Frequency (VLF) communication transmission station. According to the chief minister's office (CMO), the station will be completed by 2027. The navy uses VLF communication transmission stations to communicate with ships and submarines.
- The Eastern Naval Command in Visakhapatnam has already identified Telangana as a suitable area for setting up a second radar station. Since 2010, the navy has been in touch with the state government.

Aviation watchdog DGCA has slapped a fine of 1.10 crore on Air India for safety violations with respect to flights operated on certain long routes

- Aviation watchdog DGCA has imposed a penalty of Rs 1.10 crore on Air India for safety
 violations with respect to operations of its leased Boeing 777 planes to the US while the
 airline said it plans to appeal against the regulator's decision. This is the second time in a
 week that the regulator has penalised Air India.
- The regulator carried out a detailed probe after receiving a voluntary safety report from an airline employee alleging safety violations of flights operated by Air India on certain long range terrain critical routes

India Ranked Second Largest Steel Producer in the World

- India is the world's second largest steel producer and it achieved another distinction in 2022
 as total production rose compared with the previous year, even as most other top producers
 registered a dip. India has become the world's second-largest steel producer, signifying
 remarkable progress in the steel industry.
- According to the Ministry of Steel, domestic steel production was around 90 million tonnes, with domestic steel consumption at 87 million tonnes. According to the report, the Production Linked Incentive Scheme increased investment in the steel sector. This year, a Memorandum of Understanding was inked with 27 companies covering 57 projects totalling over 29 crore rupees.

Naila Kiani becomes first Pakistani woman to summit world's 10th highest mountain

- Pakistan's Naila Kianihas become the first woman from the country to summit 8,091m high Annapurna I in Nepal.Kiani, mother of two and a banker in Dubai, reached the top of the world's 10th highest mountain.She scaled Annapurna I along with Pakistani mountaineer Shahroz Kashif.
- The six-member team included two Pakistanis and India's Arjun Vajpayee.Kiani's summit was announced by her expedition organisers Seven Summit Treks.She has also become the first Pakistani woman to scale four peaks of over 8,000m.

UP ranks First in the Inter-Operable Criminal Justice System for 3rd Consecutive Year

- Uttar Pradesh has ranked first for the third consecutive year in recording the highest entry rate on the Inter-Operable Criminal Justice System (ICJS) platform, conceptualized by the Supreme Court's e-committee and implemented by the ministry of home affairs.
- The ICJS platform facilitates seamless transfer of data and information among various pillars
 of the criminal justice system nationwide. By enabling data interchange between all
 stakeholders through a common digital interface, the ICJS platform reduces paperwork and
 delays. It assists speedy administration of justice while aiding officers with decision-making
 via comprehensive analytics.

- The training programme was virtually inaugurated for the first batch of 30 trainees (Vishwakarma) in 'darzi craft' by Advisor to Lieutenant Governor, Rajeev Rai Bhatnagar, and Secretary of the Union Ministry of Skill Development and Entrepreneurship (MSDE), Atul Kumar Tiwari, at ITI Shopian, the report added.

Uttar Pradesh investor base surpasses Gujarat to rank second with 89.47 lakh stock market investors



PM Launhes Khelo India Youth Games 2023 In Chennai, Tamil Nadu

- Prime Minister Narendra Modi declared the Khelo India Youth Games 2023 open at the Nehru Indoor Stadium in Chennai. The opening ceremony of the national sports event took place in a grand fashion with several cultural programmes exhibiting the traditional and cultural practices of Tamil Nadu.
- The event, which is being held for the first time in a south Indian state, will feature over 5,600 athletes. The games will be played across four cities of Tamil Nadu, including Chennai, Madurai, Trichy, and Coimbatore, from January 19 to January 31. The games will feature 26 sporting disciplines with a mix of conventional sports and traditional ones.



Tata Sons secures the IPL title sponsorship for the next five seasons

- The Tata Group has extended its title sponsorship of the IPL for another five years, from 2024 to 2028, for INR 2500 crore (US\$301 million approx.), making it the "highest-ever sponsorship amount in the history of the league," a BCCI statement said. The group were the IPL title sponsors in 2022 and 2023, and are also the title sponsors of the Women's Premier League (WPL).

"The recordbreaking sum of INR 2500 crore by TATA Group is a testament to the immense value and appeal that the IPL holds in the world of sports.

Chirag Shetty and Satwiksairaj finished second in the India Open title 2024

Tata remains IPL title sponsor in record-breaking US\$300m deal

- Tata Group has been the title sponsor of both the men's IPL and the Women's Premier League. The Indian Premier League (IPL) is a men's Twenty20 cricket league. It is annually held in India. The league is contested by ten city-based franchise teams. The BCCI founded the league in 2007.

Rohan Bopanna becomes oldest player to hold No.1 men's tennis doubles ranking

- Indian tennis sensation Rohan Bopanna became the oldest player to hold the No. 1 men's doubles ranking. The 43-year-old Ace player, alongside Australia's Matthew Ebden defeated the Argentine pair Máximo González and Andrés Molteni in straight sets 6-4, 7-6 in the 2024 Australian Open quarter-finals.
- After becoming the World No. 1, Bopanna said that his achievement will inspire the people all over the world, being 40 and above in a different way. Bopanna had made his debut more than 20 years ago. He will be 43 years and 330 days old at the end of the tournament.

India's Sahil Thakur finishes 47th in giant slalom in winter youth Olympics 2024.It was held in South Korea country

- The men's giant slalom race comprised a field of 79 athletes. Sahil was placed 62nd among the 65 competitors, who finished the first run and earned a starting spot in the second run. Sahil, who is only Indian athlete competing at Gangwon, finished the second run to be placed 47th among the 50 competitors who finished run in the final standings.
- Gangwon 2024 is the first time the Winter Youth Olympic Games is being held in Asia. Around 1,900 athletes, with an equal representation of males and females, from 80 countries, are competing in Gangwon.

ICC announces groups for T20 Men's Cricket World cup 2024

- The 20 teams have been divided into four groups, with five sides in each group. The top two teams from each group will qualify for Super Eights, and the top two teams from each group will proceed to the semi-finals. The tournament will kick off with the first match to be played between co-host USA and Canada in Dallas. The blockbuster clash between India and Pakistan is scheduled for June 9 in New York.
- This is the very first time 20 teams will be participating, and it will also feature the African nation of Uganda, which has qualified for the first time in any ICC World Cup.A total of 55 matches will be played across nine venues, with six stadiums located in the West Indies and



the rest in the USA. Super Eight matches, along with the knockout stage, will be played in the West Indies.

- The 26-year-old Nagal, who fought his way into the main draw through the qualifiers, displayed exceptional skill and determination to beat Alexander Bublik with a scoreline of 6-4, 6-2, 7-6(7-5) in a grueling match that lasted two hours and 38 minutes. This victory marks Nagal's debut progression to the second round and a significant milestone in his tennis career.

Rohit Sharma tops list of batters with most hundreds in T20I



- The match between India and Afghanistan became the first in international cricket to feature two Super Overs. It is only the second T20 match to have two super overs Mumbai Indians vs Kings XI Punjab in the IPL in 2020 was the first.
- 424 Runs aggregated by India and Afghanistan in Bengaluru are the second most in a T20I to have ended in a tie. Four-hundred-and-twenty-eight runs in the 2010 Christchurch T20I between New Zealand and Australia are the highest, with both teams scoring 214.

- India's oldest female sloth bear, whose name was Gulabo, has passed away at the Van Vihar National Park and Zoo, located in Bhopal, Madhya Pradesh. Gulabo was the oldest sloth bear of the country. 
