# 1. Mark Carney Succeeded Justin Trudeau as the Next Prime Minister of Canada

Mark Carney has succeeded Justin Trudeau as the Prime Minister of Canada, marking a significant shift in the country's leadership. A former Governor of the Bank of Canada and the Bank of England, Carney brings extensive economic expertise to the role. - **Similar Schemes**: The Mahila Samriddhi Yojana is similar to financial assistance schemes for women in other NDA-ruled states, such as the 'Ladli Behna Yojana' in Madhya Pradesh and the 'Ladki Bahin Yojana' in Maharashtra.
