Alfiya Pathan and Gitika win Gold at Elorda Cup in Nur-Sultan, Kazakhstan.

1. Alfiya Pathan and Gitika win Gold at Elorda Cup in Nur-Sultan, Kazakhstan

- Two Indian female boxers, Alfiya Pathan (81 kg) and Gitika have won gold medals at the Elorda Cup in Nur-Sultan, Kazakhstan.
- Kalaivani Srinivasan and Jamuna Boro have signed off with silver medals.
- Alfiya has defeated 2016 world champion, Lazzat Kungeibayeva by a 5-0 margin.
- While Gitika has beat Kalaivani in all-Indian women's 48 kg final.
- Indian contingent concluded the campaign with two gold, two silver, and 10 bronze.

3. GST collections increased to Rs 1.44 lakh cr in June 2022

- Collection of Goods and services tax (GST) in June 2022 has jumped to 56% year-on-year to touch Rs 1,44,616 crore.
- The GST collection raised due to economic recovery and anti-evasion drives such as action against fake billers.
- Goods and Services Tax (GST) collections in June, 2021 stood at \square 92,800 crore.
- This is the second-highest collection ever, after the April 2022 mop-up of Rs 1,67,540 crore.
- CGST: Rs 25,306 crore; SGST: Rs 32,406 crore; IGST: Rs 75,887 crore and cess is Rs 11,018 crore.

4. Payment operators need RBI nod for merger and acquisition

• Non-bank payment system operators (PSOs) shall require approval from the RBI in following cases:



05 JULY, 2022

- 1. For any takeover or acquisition of control, which may or may not result in change of management.
- 2. Sale or transfer of payment activity to an entity not authorised for undertaking such an activity
- The RBI shall respond within 45 calendar days after receipt of complete details.
- The authorised non-bank PSO should inform DPSS, CO, RBI within 15 calendar days.



5. RBI imposes penalties on Kotak Mahindra Bank and IndusInd Bank

- The RBI has imposed a monetary penalty of Rs 1.05 crores and Rs 1 crore on Kotak Mahindra Bank and IndusInd Bank respectively.
- Reason: For deficiencies in regulatory compliance.
- Kotak Mahindra Bank has failed to maintain margin on advances to stock brokers, credit the amount involved in the unauthorised electronic transactions to the customers' account.
- IndusInd Bank has failed to adhere to customer due diligence procedure in the accounts opened using OTP based e-KYC.

6. Tata Power signs MoU with Tamil Nadu government for solar plant

- Tata Power has signed an MoU with Tamil Nadu government to invest Rs 3,000 crore for setting up a greenfield 4GW solar cell and 4 GW solar module manufacturing.
- The plant will be set up in Tirunelveli district of Tamil Nadu.
- Tata Power has also built a manufacturing unit in Bangalore, which has a production capacity of 635 megawatts of modules and 500 megawatts of cells.

9. Rahul Narwekar becomes the youngest Speaker in the country

- Rahul Narwekar was elected as the 16th Speaker of the Maharashtra Legislative Assembly after defeating Rajan Salvi (Shiv Sena candidate).
- The post of the Maharashtra Speaker was vacant after Nana Patole (Congress) resigned from the office in February 2021.







- The Deputy Speaker Narhari Zirwal was playing as an acting Speaker in the House.

10. Veteran filmmaker, Tarun Majumdar passes away at 91

- Veteran filmmaker, Tarun Majumdar has passed away in Kolkata at 91.
- He was known for his sensitive portrayal of middle-class life and the human condition in his film.
- He has won National Award four-times and received Padma Shri.
- His first directed film was Chawa Pawa (1959), starring Uttam Kumar and Suchitra Sen.
- In 1962, he directed Kancher Swarga, which won the National Award for the best feature film in Bengali.
