# Centre approves reconstruction plan worth over 1658 crore rupees for Joshimath in Uttarakhand

- The Union government approved the Recovery and Reconstruction (R&R) plan of Rs 1658 crore for subsidence-hit Joshimath town. The decision was taken by a high-level committee, headed by Union home minister and minister of cooperation, Amit Shah.
- As per the approved plan, Rs 1080 crore of central assistance will be allocated from the National Disaster Response Fund. A High-Level Committee under the chairmanship of Union Home Minister Amit Shah approved the plan.

#### Vice President says retired judges keeping country's arbitral system in tight fist grip

The plan seeks to rename the city after Raja Chandra Sen, who ruled the region in the 16th century, people familiar with the matter.

For the enhancement of Rural Tourism in India the Ministry of Tourism, Government of India launched the comprehensive National Strategy and Roadmap for the Development of Rural Tourism in India, along with the National Strategy for the Promotion of Rural Homestays.

# Tamil Nadu Chief Minister Stalin Announces Establishment of Footwear Park with a Budget of Rs 400 Crore

- The Tamil Nadu government has planned to set up a footwear manufacturing park at an outlay of Rs 400 crore on a 250-acre land. The industrial project would generate 20,000 new jobs in Ranipet district.

• In a major diplomatic win, Pakistan emerged victorious over India in the elections for the Vice Chair position on the UNESCO Executive Board for the term 2023-2025. The elections,



- held during the 218th Session of the UNESCO Executive Board in Paris, saw Pakistan securing an impressive 38 votes out of the 58-member board, while India received 18 votes.
- The scheme mandates a complete transition to electric vehicles (EVs) for all cab aggregators and delivery service providers by 2030.

#### Congress announces Revanth Reddy as CM of Telangana

- The Congress central leadership has named Telangana party chief A. Revanth Reddy as its choice of Chief Minister of the State. He will take the oath of office on December 7.Mr. Reddy was named the leader of the Congress Legislature Party (CLP), and he will become the first Congress Chief Minister of Telangana, a State formed in 2014.
- Born in 1969 at KondareddyPally village in the present Nagurkurnool district in Telangana, he entered politics in 2006 and was elected as Zila Parishad member. He was later elected as Member of Legislative Councul as independent from MLAs quota. He won from Kodangal Assembly constituency in 2009 from TDP and again in 2014.

#### Madagascar Court Upholds Andry Rajoelina's Presidential Election Victory

- Madagascar's Constitutional Court has confirmed President Andry Rajoelina re-election following a controversial election a fortnight ago. The court said Mr Rajoelina secured 59% of the votes cast, declaring him elected for a third term.
- It dismissed complaints by the opposition over the credibility of the vote, which recorded a low turnout of 46%.10 out of 13 presidential contenders had withdrawn their candidacies but their names remained on the ballot.

#### Union Minister Ashwini Vaishnaw inaugurates new factory of Dixon Technology in Noida

- Padget Electronics, a wholly owned subsidiary of Dixon Technologies, inaugurated a new smartphone manufacturing facility in Noida in the presence of Union Minister of Electronics. This new factory of Dixon Technology will boost the local manufacturing of smartphones.
- The company has invested Rs 256 crore in the facility that takes up 2.7 lakh square feet and has an annual capacity of 25 million units, the company said in a statement."It is a momentous step towards our commitment of boosting the local smartphone manufacturing system in India," Sunil Vachani, executive chairman, Dixon Technologies said in a statement.

India to Extend \$250 Million Line of Credit to Kenya for the Modernization of its Agricultural Sector



- India extended a \$250 million Line of Credit for modernisation of agriculture in Kenya. Announcing the initiative PM Modi said both sides will carry out joint military exercises and will collaborate on counter-terror projects.
- India is willing to share its experience in developing Digital Public Infrastructure with Kenya. Mr Modi also announced that Kenya has expressed interest in joining the International Solar Alliance and Global Biofuels Alliance.

- Telangana Congress President, Anumula Revanth Reddy, appointed as the new Chief Minister of Telangana. Revanth Reddy was named the Leader of the Congress Legislature Party (CLP), marking his ascent as the first Congress Chief Minister of Telangana, a State formed in 2014.
- The swearing-in ceremony is scheduled for December 7, 2023 in Hyderabad, where Revanth Reddy will officially take office.

#### Government decides to implement component of "Nari Adalat" in phased manner

- Union Minister for Women and Child Development Smriti Irani has informed the Rajya Sabha that the Government has decided to implement the component of "Nari Adalat" in a phased manner under Mission Shakti.
- In a written reply to a question, the Minister said in the first phase, Assam and the Union Jammu and Kashmir have been selected by her Ministry to implement the component of Nari Adalat. In Jammu and Kashmir, it is being implemented in two aspirational districts Kupwara and Baramulla and in Assam, seven districts namely Barpeta, Goalpara, South Salmara Mankachar, Udalguri, Darrang, Morigaon and Kamrup have been covered under it.


### Govt Unveils 'Mera Goan, Meri Dharohar' Project to Document village Heritage

#### Lok Sabha Discusses Jammu and Kashmir Bills for Reservation and Reorganisation

- The Jammu and Kashmir Reservation (Amendment) Bill, 2023, amends the Jammu and Kashmir Reservation Act, 2004. The Act provides reservation in jobs and admission in professional institutions to members of Scheduled Castes, Scheduled Tribes, and other socially and educationally backward classes.
- On the other hand, the Jammu and Kashmir Reorganisation (Amendment) Bill, 2023 amends the Jammu and Kashmir Reorganisation Act, 2019. The 2019 Act amended the Second Schedule of the 1950 Act to specify the total number of seats in the Jammu and Kashmir Legislative Assembly to be 83. The proposed Bill increases the total number of seats to 90.

### Prime Minister Shri Narendra Modi Gives Green Signal to Chennai's First Urban Flood Mitigation Project Worth 561.29 Crore

• Prime Minister Narendra Modi approved the first urban flood mitigation project worth 561.29 crore for 'Integrated Flood Management Project' for the Chennai Basin Project, Union home minister Amit Shah said in a statement.



• The project includes Centre's assistance of 500 crore and the mitigation project will help make Chennai flood-resilient. This happens to be the first in a series of urban flood mitigation efforts and will help develop a broader framework for urban flood management.

#### **PM Formalization of Micro Food Processing Enterprises Scheme**

- The centrally sponsored Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME) Scheme was launched on 29th June, 2020 by the Ministry of Food Processing Industries, Government of India under the Aatmanirbhar Bharat Abhiyan.
- The scheme has completed two years and a journey that started with the zest to empower the unorganized Micro Enterprises continues to fulfill the aim of formalising the food processing sector and celebrating their tremendous support towards the economy, has borne good results for the sector.

#### India to spend 57 lakh crore rupees on adaptation to climate change over next 7 years

- New Delhi told UN Framework for Climate Change Convention (UNFCCC) that India has spent about 13.35 lakh crore in 2021-22, just over 5.5 percent of its GDP, on climate adaptation and expects to incur another about 57 lakh crore rupees over the next seven years for this purpose.
- This is India's latest submission filed that includes its first assessment of adaptation requirements. But this is only in the business-as-usual scenario, that is only if climate vulnerability does not deteriorate during this period. Climate-induced damage could escalate this amount by another 15.5 lakh crore rupees.

### Clean Ganga Mission signs pact with Mississippi River Initiative

- The National Mission for Clean Ganga (NMCG) recently signed a Memorandum of Common Purpose (MoCP) with the Mississippi River Cities and Towns Initiative (MRCTI), which represents 124 cities/towns situated along the banks of the Mississippi River, the United States.
- NGRBA has since been dissolved with effect from 2016, consequent to the constitution of the National Council for Rejuvenation, Protection and Management of River Ganga (referred to as National Ganga Council).

#### India's 1st Telecom Centre of Excellence to come up in Uttar Pradesh's Saharanpur

• The Uttar Pradesh (UP) government has announced plans to build India's first Telecom Centre of Excellence in Indian Institute of Technology (IIT) Roorkee. The state government



has announced to shell out as much as Rs 30 crore in establishing a research centre at IIT Roorkee in Saharanpur.

• According to the state government, the new centre will not just widen UP's participation in technology and innovation but will also propel the telecommunications sector.

#### India's emission intensity reduced by 33% between 2005 and 2019

- India firmly believes that equity and climate justice must be the basis of climate action and this can be ensured only when the developed countries take the lead in combating climate change, Environment Minister Bhupendra Yadav said here at the COP28.
- Delivering the national statement at the high-level segment during the ongoing annual climate conference, Mr Yadav also highlighted India's contribution to the global actions in restricting temperature rise by reducing emission intensity much ahead of the promised target year as mentioned in the Nationally Determined Contributions (NDCs), country's action plan for dealing with the impacts of climate change.

# NHAI Inks Agreement to Develop Multi Modal Logistics Park at Nagpur at a cost of Rs. 673 crores

- The MMLP will be developed in an area of 150 acres under the Public Private Partnership model at an estimated cost of Rs.673 crore. This project is poised to be the first MMLP in Maharashtra under the PM Gati Shakti National Master Plan, making it a significant milestone in the country's development.
- The MMLP will be developed in three phases. The Phase-I with an investment of Rs. 137 crore is expected to be completed in two years. MMLP will cater to about 9.47 million metric tonnes (MMT) cargo in the horizon period of 45 years and will give huge boost to the industrial zones in the catchment region such as Nagpur, Wardha, Chandrapur and Gondiya.

#### India's Retail Inflation 5.55 per cent in November 2023

- India's retail inflation surged sharply to 5.55 per cent in November after falling to a fourmonth low of 4.8 per cent in October, according to data released by the Ministry of Statistics & Programme Implementation.
- The uptick in retail inflation has been attributed to a sharp rise in food prices. Notably, the food inflation for November registered at 8.70 per cent. While inflation remains within the RBI's comfort zone, the surge in inflation could make the central bank's job difficult going forward.

India's re-election falls under the Category of 10 states with "the largest interest in international seaborne trade", alongside Australia, Brazil, Canada, France, Germany, the Netherlands, Spain, Sweden and the United Arab Emirates (UAE).

#### **Centre Greenlights Resumption of GIAN Scheme in Fourth Phase After COVID Hiatus**

- Eight years after its inception, the Ministry of Education is gearing up to restart the fourth phase of the Global Initiative of Academic Networks (GIAN).
- The National Institute of Educational Planning and Administration (NIEPA), after evaluating the scheme, recommended its continuation. Since the beginning of the scheme in 2015-16, 1,612 foreign faculty members have visited the country to deliver courses from 59 countries.

#### India and China Opt Out of Pledge alongside 118 Nations at COP28

- India and China, two major economies and leading coal consumers, chose not to join a pledge made by 118 nations at the UN's climate summit (COP28). The pledge aimed to triple the global capacity for renewable energy generation to at least 11,000 GW and double the average annual rate of energy efficiency by 2030.
- A total of 118 countries, including Japan, Australia, Canada, Chile, Brazil, Nigeria, and Barbados, supported the initiative to triple global renewable energy capacity by 2030 during the UN's climate talks. The primary goal of the pledge is to decrease reliance on fossil fuels in global energy production.

#### **UPI Transaction Value Hits Record ₹17.4 Lakh Crore in November 2023**

- UPI transactions hit a new record of Rs 17.4 lakh crore in November 2023, however, volumes dipped marginally from 11.4 billion in October to 11.2 billion reflecting the fewer days and the end of sales.
- Compared to a year ago, UPI transactions increased by 54% in terms of the number of transactions and by 46% in terms of value. UPI transaction volume declined slightly to 1,124 crore from 1,141 crore in October.

### China Adopts 'One Province, One policy' Approach to Financial Risk Management

UGC had earlier declared the MPhil degree illegitimate, instructing higher educational institutions not to offer MPhil programmes.

- The Reserve Bank of India (RBI) and the Bank of England (BoE) took a significant step towards fostering international financial cooperation by signing a Memorandum of Understanding (MoU). The focus of this MoU is on collaboration and the exchange of information related to the Clearing Corporation of India Ltd (CCIL).

#### RBI Grants Approval for CSB Bank Promoter to Maintain 26% Stake in the Lender

- The promoter of India's CSB Bank has received approval from the Reserve Bank of India to retain a 26% stake in the lender, instead of 15% as advised by the central bank earlier, CSB. However, following a legal battle with Uday Kotak, the promoter of Kotak Mahindra Bank, the regulator permitted promoters to retain up to 26% in banks.
- FIH Mauritius Investments Ltd (FIHM), which currently holds a 49.72% stake in the Thrissur, Kerala-based bank according to BSE data, shall bring down its shareholding within 15 years from the date of completion of investments.

# RBI Allows Banks to Open Current Accounts for Export Proceeds Alongside Special Rupee Vostro Accounts

- The Reserve Bank of India (RBI) permitted banks to open additional current accounts for export proceeds in addition to special rupee vostro accounts with a view to provide greater operational flexibility to exporters.
- To provide greater operational flexibility to exporters, banks maintaining a special rupee vostro account as per the provisions of the RBI circular dated July 11, 2022 are permitted to open an additional special current account for its exporter constituent exclusively for settlement of their export transactions.

Private general insurers expand market share to 53.58% in H1 FY24



- In the first half of FY24, private general insurance companies (insurers) boosted their combined market share to 53.58% in gross direct premium underwritten from 50.81% in the corresponding period a year ago.
- About 31 insurers from the non-life industry had underwritten gross direct premiums of Rs
   1.43 lakh crore in the first six months of FY24, as per the data on segment-wise gross direct
   premiums up to September 2023, as per data of Insurance Regulatory and Development
   Authority of India (IRDAI).

#### Bharti Airtel becomes the 8th company to surpass 6 lakh crore Mcap

- The full market capitalisation of Bharti Airtel (partly plus fully paid-up) hit ₹6 lakh crore for the first time on Monday, after Bharatiya Janata Party's (BJP) resounding victory in state elections buoyed the overall market sentiment.
- Share of Bharti Airtel added another 2%, taking their year-to-date gain to 28%. In contrast, the benchmark Nifty has gained 14.3% during the same period. The stock has been generating positive returns for the last five years, with 2019 being the highest.

The process of recovery of dues from the borrower in written-off loan accounts continues.

• SBI currently holds a 60 percent stake in SBI Pension Funds. Through this latest transaction, the company is set to increase its stake to 80 percent, acquiring the additional shares for a sum of ₹ 229.52 crore. The remaining 20 percent stake in SBI Pension Funds is held by SBI Funds Management.



• In its regulatory statement, SBI noted that both the Reserve Bank of India (RBI) and the Pension Fund Regulatory and Development Authority (PFRDA) have given their approval for the planned acquisition. The remaining 20% stake in SBI Pension Funds is held by SBI Funds Management.

- Sandeep Batra has been serving as ED on ICICI Bank's Board, overseeing the Corporate Centre since July 2018. His responsibilities span across crucial domains, including credit, corporate communications, data science, finance, human resources, legal, operations, customer service, technology, and secretarial groups. Additionally, he holds administrative responsibility for the risk function, internal audit, and compliance groups.

#### LIC gets time till 2032 to follow 25% public shareholding rule

- State-owned India's largest insurer LIC or Life Insurance Corporation of India has been exempted till 2032 to follow 25% minimum public shareholding norms. In May 2022, the government had sold 3.5% stake in LIC IPO, which was an entirely (offer for sale) worth around Rs 21,000 crore. It remains India's largest IPO to date.
- The stock is now down around 19% from its IPO issue price of Rs 949 per share. LIC shares ended 0.5% higher at Rs 764.55 on the BSE. However, in the last few weeks the stock has seen fresh buying interest. In the last one month alone LIC is up 25%.

#### SEBI proposes option of T+0, instantaneous settlement for equity cash segment

- Market regulator Securities and Exchange Board of India (SEBI) in a consultation paper has
  proposed the implementation of optional T+0 and instant settlement cycle of trades in the
  equity cash segment.
- SEBI introduced the T+3 settlement cycle in 2002, the T+2 settlement cycle was introduced in 2003 and the current T+1 settlement cycle was introduced in 2021 and was fully implemented by January 2023.

### SBI Mutual Fund Acquires 1.5% Stake in Karur Vysya Bank for Rs 190 Crore

• SBI Mutual Fund acquired shares of scheduled commercial bank Karur Vysya Bank (KVB) for Rs 190 crore through open market transactions. According to the bulk deal data available with the BSE and NSE, SBI Mutual Fund (MF) purchased a total of 1,20,00,000 shares, amounting to a 1.5% stake in Karur Vysya Bank.



• The shares were picked at an average price of Rs 162 apiece on both bourses, taking the combined aggregate deal size to Rs 194.40 crore. Shares of Karur Vysya Bank rose 1.32 per cent to close at Rs 164.90 apiece on the BSE and gained 0.52 per cent to settle at Rs 164.70 per piece on the NSE.

#### India set to launch its first X-Ray Polarimeter Satellite – ISRO

- India is preparing to launch its inaugural X-Ray Polarimeter Satellite (XPoSat) using the Polar Satellite Launch Vehicle (PSLV) from the Satish Dhawan Space Center in Sriharikota, Andhra Pradesh.
- Two scientific payloads onboard will observe X-Ray sources during the spacecraft's transit through Earth's shadow (eclipse period). The spacecraft will carry two scientific payloads in a low earth orbit.

The 'Prasthan' is conducted to validate measures and procedures to address various contingencies that may arise in the oil production platforms and was held in two phases.

#### Russia Unveils two new Nuclear- Powered Submarines

- President Vladimir Putin unveiled two new nuclear-powered submarines that he said would soon start patrolling the Pacific. He oversaw the raising of navy's flag on the newly built nuclear submarines. Speaking at the shipyard, Mr Putin pledged to carry out plans to modernise the Russian navy.
- The Emperor Alexander III is the seventh Borei-class atomic-powered submarine to enter the service. Each of them is armed with 16 nuclear-tipped Bulava intercontinental ballistic missiles. Mr Putin announced that three more such submarines are under construction.

#### IAF Successfully Testfires 'SAMAR' Air Defense Missile System In Andhra Pradesh

- In a major success for its in-house design and development efforts, the Indian Air Force has successfully testfired its SAMAR air defence missile system. The IAF has developed the Surface to Air Missile for Assured Retaliation (SAMAR) air defence missile system by using its old Russian-origin air-to-air missile systems.
- SAMAR is a quick reaction surface-to-air missile system, ingeniously crafted by the IAF's 7 Base Repair Depot (BRD) and 11 BRD, in collaboration with Simran Flowtech Industries and Yamazuki Denki. Notably, the system repurposes old Russian-origin Vympel R-73 and R-27 air-to-air missiles, demonstrating an innovative approach to maximize existing resources.

#### Defense Ministry Greenlights Acquisition of 6,400 Rockets for Pinaka Weapon System

• The Ministry of Defence (MoD) has given the green light for the acquisition of 6,400 new rockets for the Pinaka weapon system. The Defence Ministry has given approval to Rs 2,800



- crore proposal for buying around 6,400 rockets for Pinaka multi-barrel rocket launcher systems.
- At its recent meeting, the Defence Acquisition Council approved the proposal for the acquisition of two types of these rockets, called Area Denial Munition Type 2 and Type-3. The Indian army is mandated to procure the rockets exclusively from indigenous sources, emphasizing self-reliance in defense capabilities. Two main contenders include the Economic Explosives Limited of Solar Industries and the Munitions India Limited.

# Tesla Introduces 'Optimus Gen 2,' an Advanced Humanoid Robot Designed to Automate Repetitive Tasks

• Tesla has unveiled "Optimus Gen 2", a new generation of its humanoid robot that should be able to take over repetitive tasks from humans. Optimus, also known as Tesla Bot, has not been taken seriously by many outside of the more hardcore Tesla fans, and for good reason. 

- Ramanujan was born in 1887 to an Iyengar Brahmin family in Erode, Tamil Nadu. Despite having little formal schooling, he mastered trigonometry at the age of 12 and created a number of his own theorems. In 1918, he also became a Fellow of the Royal Society, one of the youngest individuals to hold this prestigious status.
